At the conclusion of this course, the student will be able to:

- Identify the United States victim laws that govern criminal justice entities and protect crime victims.
- Recognize how crime impacts victims and/or their families.
- Develop how to communicate effectively with victims and survivors of crime.
- Describe the role that ethics play in crime victim services.
- Identify the resources that are available to crime victims, survivors, and their families.
- Describe the direct services that are made available and are provided to crime victims.
- Assess the importance of advocacy when assisting crime victims navigate the justice system.

III. METHODS OF ASSESSING ACHIEVEMENT OF STUDENT LEARNING OUTCOMES:

- 1) Discussion Boards (original posting with references in APA format): (20pts X 7) 140pts
- 2) Interaction with classmates by commenting on or asking a thought-provoking question to a minimum of 2 classmates on the Discussion Boards (to include references in APA format): (16pts X 14) 224pts
- 3) Final Paper & Power-Point: APA formatting w/running head, title page, abstract page, 3-5 typed body pages (double-spaced, Times New Roman, 12 point) and reference page.

V. CONTENT OUTLINE:

- A) Read all assigned material(s) each week.
- B) Complete and be prepared with all assignments.
- C) Participate in class Discussion Boards.
- D) Complete Discussion Boards, Final Paper, and Power Point as scheduled.

E) Discussion Boards:

For each week's class session, you will be required to write an original post to that week's Discussion Board assignment with a three paragraph minimum (a paragraph is considered to be 4-5 sentences). Additionally, you will be required to participate and post two (2) one-paragraph (minimum) responses to two (2) other classmates (this can be a thoughtful comment or a thought-provoking question). Discussion Boards are worth 20pts (the original post) & each of the two required posts are worth 8pts each, for a total of 16pts. For full credit, the original post and responses must have good content/substance, a minimum of two academic sources, correct APA formatting, and good mechanics/grammar (see course rubric for other

specifics). Posts should reflect your thoughts (while applying what you have learned) after considering the topic(s) at hand and discussion. It is also an exercise designed to provide you with an opportunity to express your opinions and perspectives while citing references to validate your argument.

Original Posts: Due: Wednesday by 11:59 EST Responses (2) to Posts Due: Sunday by 11:59 EST

Final Paper/PP: Final paper will be an in-depth study of 1 of 5 available topics that the student will choose from. The final paper will be due at the end of the final week of the course. The **topic** must be chosen from the list and be submitted to the instructor by the end of the third week of the course. The student should begin incorporating lessons learned throughout the course to apply to their final paper and work on the paper as the course progresses. The paper will be APA formatted (see IV and the course rubric for specifics on grading and available credit). The paper should include a cover sheet, 3-5 typed, double-spaced, Times Roman, 12pt content pages, and a reference page. The **Power-Point** will be a minimum of 8-10 slides.

Information will be presented and learned through the online classroom Discussion Boards and responses, and through the required weekly assignments. *Students are responsible for all materials and assignments*. Discussion Boards will also be used for attendance and will be maintained for grade purposes. Excessive delays may result in a failing grade for the course and may result in the Loss of Financial Aid. Exceptions are pre-approved delays or personal documentable delays that are beyond the student's control. After reviewing the reason given for the delay, discretion may allow the student to make up the work missed. More than two delays, and you may fail the course. Students who do not meet the Discussion Board requirements, will be subject to administrative withdrawal as specified in the University Catalog. Doing Discussion Boards is important, but, what you say and how you say it, is equally valuable.

Assignments: All graded assignments are due on the date
