

Credit Hours: 3 Contact Hours: This is a 3-credit course, offered in accelerated format. This means that 16 weeks of material is covered in 8 weeks. The exact number of hours per week that you can expect to spend on each course will vary based upon the weekly coursework, as well as your study style and preferences. COURSE DESCRIPTION AND OUTCOMES

COURSE DESCRIPTION: In this course, students examine the definitions, theories, and causes of victimization. Topics also include the criminal and civil processes available to protect and restore victims of crime. The social, personal, and economic impacts of crime on individuals, organizations, and society are also examined.

COURSE OVERVIEW: The course will focus on victim's rights, preventive measures, and the concepts of compensation and restitution. The course will close with a summary of victim empowerment through the use of legislation, the media, public discourse, and private enterprise.

The goal of this course is to make the student a more informed critic and analyst of the world of crime, criminology, and victimology. It is hoped that by the end of the course, you will be better able to explain the impact of crime on victims; a global perspective of victimization; and responses to victimization. As a student of criminology, you should develop the ability to better interpret the changing world of crime, become a more informed citizen, and be better prepared to enter the world of professional criminology and criminal justice.

Option #1: Domestic Violence Victims' Reporting Behavior and Court Proceedings

Read the article: "Domestic Violence Reported to the Police: Correlates of Victims' Reporting Behavior and Support to Legal Proceedings," linked on the Assignment page.

As a consultant to a local domestic violence resource center, you have been asked to train staff on the subject of domestic violence victims' reporting behavior and court proceedings. For this

assignment, you are to prepare 5- to 7-slide PowerPoint or Prezi presentation with speaker notes with each slide of no fewer than 50 words and title and reference slides (not counted in the 5- to 7-slide total). (For guidance on preparing a visual presentation, click on the link provided in your assignment to visit the library's resources.) Your presentation should address: (1) reasons domestic violence victims are apprehensive to report the incidents; (2) motivations of domestic violence victims to call the police; and (3) factors that influence a victim's reporting of the incident.

You will also make recommendations on how to: (4) increase victim involvement in criminal proceedings; and (5) identify civil remedies available to victims of domestic violence.

Within your presentation, you will support your work with at least two peer-reviewed, academic sources, in addition to the course textbook. Your presentation, references list, and sources should be formatted according to the CSU-Global Guide to Writing & APA.

Option #2: Domestic Violence: Abuse of the Civil Courts

Read the article: "How Domestic Violence Batterers Use Custody Proceedings in Family Courts to Abuse Victims and How Courts Can Put a Stop to It," linked on the Assignment page.

Civil courts have long been a viable option to help serve victims of domestic violence, whether it is to allow victims to file restraining orders; to protect children from battering parents; or to provide civil remedies for financial support in the form of restitution, child support, and related needs. As Campbell noted in her article, however, domestic violence batterers use custody proceedings in family courts to abuse victims.

For this assignment, you will explain how civil courts, including family courts, may serve as venues to protect and assist victims of domestic violence. You will also evaluate Campbell's position that these courts may also further abuse victims of domestic violence. What can be done to protect victims from this subsequent victimization?

Your paper should be 2-3 pages in length and conform to the CSU-Global Guide to Writing & APA. Include at least three scholarly references, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Option #1: Victim Restitution and Compensation

As you have learned in this week's readings, both state and federal governments provide financial resources for victims of crime. However, the costs of crime and crime-related expenditures, including victim compensation programs and governmental reimbursement programs for crime victims, continue to be controversial.

For this assignment, you will compare and contrast restitution and compensation programs. You must include some discussion on how these programs can assist victims of crime.

You will also provide an overview of the arguments, both for and against, the establishment of victim compensation funds by state and federal governments using tax revenue. Finally, you will provide an overview of your state's victim compensation program, including eligibility criteria, a summary of the process, and payout limits and exclusions. (If your state does not have a program, select another state geographically adjacent to or near your state.)

Your paper should be 2-3 pages in length and conform to the CSU-Global Guide to Writing & APA. Include at least three scholarly references, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Option #2: Global Comparisons of Victim Restitution and Compensation Programs

In 1985, the General Assembly of the United Nations adopted the Declaration of Basic Principles of Justice for Victims of Crime and Abuse of Power. Provisions of the Declaration include financial compensation to victims of crime, and in some instances, their family members, and the recommendation that national and state governments create and maintain funds for this purpose (United Nations General Assembly, n.d.).

For this assignment, you will choose two countries, not including the United States, and evaluate their victim compensation policies. You will provide an overview of each country's victim compensation and restitution programs, including eligibility criteria, a summary of the process, and payout limits and exclusions. If available, provide some data about the number of program expenditures. Include some discussion on the purposes for which recipients are allowed to use these funds.

Your paper should be 2-3 pages in length and conform to the CSU-Global Guide to Writing & APA. Include at least three scholarly references, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Your paper should be 2-3 pages in length and conform to the CSU-Global Guide to Writing & APA. Include at least three scholarly references, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

- What, if any, criminal justice policies or procedures have been enacted to prevent human trafficking in your chosen country?

Your paper should be 2-3 pages in length and conform to the CSU-Global Guide to Writing & APA. Include at least three scholarly references, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Option #2: School Shootings

You are a school resource officer who has been asked to give a presentation on preventing school shootings to new faculty and staff at a local high school.

For this assignment, you are to prepare 5- to 7-slide PowerPoint or Prezi presentation with speaker notes with each slide of no fewer than 50 words and title and reference slides (not counted in the 5- to 7-slide total). (For guidance on preparing a visual presentation, click on the link provided in your assignment to visit the library's resources.) Your presentation should

include an overview and should also explain: (1) the risk factors of school violence/school shootings outlined in Chapter 6 of the Meadow's textbook; (2) the warning signs that school faculty and staff should look for; and (3) any programs and strategies that have been used to prevent school shootings.

Within your presentation, you will support your work with at least three peer-reviewed, academic sources, in addition to the course textbook. Your presentation, references list, and sources should be formatted according to the CSU-Global Guide to Writing & APA. **Portfolio Milestone (20 points)** During this week, you will complete an outline for your Portfolio Project. - Option #1: Research and Reflection Paper**

Your Portfolio Project assignment for this option is to create a research and reflection paper that synthesizes information gathered from peer-reviewed sources and your own knowledge about a chosen aspect of criminal victimization.

Be sure to read the Portfolio Project description below thoroughly before beginning to work on this option.

Portfolio Project Milestone Deliverables The following deliverables are due before midnight on Sunday of Weeks 2, 4, and 6:

- Week 2: Topic Submission (10 points of the Portfolio Project)
- Week 4: Annotated Bibliography (20 points of the Portfolio Project)
- Week 6: Portfolio Project Outline (20 points of the Portfolio Project)

Paper For your paper, discuss two theories of victimization that best explain the criminal victimization aspect you chose. Follow these instructions:

- Develop your paper with a focus on your selected theories, including their major concepts.
- Use evidence from prior research to conclude how the theories explain victimization.
- Discuss how different populations of people might be affected by your theories, such as the disabled; the elderly; the homeless; immigrants; and lesbian, gay, bisexual, and transgendered (LGBT) people. Are there any cultural issues that should be addressed? These might include female genital mutilation, rape, sexual abuse, honor killings, gang violence, and crimes against special populations (e.g., the blind, elderly, homeless, and LGBT people).
- Evaluate the limitations or weaknesses of your theories.
- What victim resources are available to support your theories?
- Your final paper must be 8-10 pages long, cite a minimum of five sources, and be formatted per the CSU-Global Guide to Writing & APA. The CSU-Global Library is a great place to find sources! Include a title page and references list page as part of the final project (but not as part of the page count). Submit your final reflection paper to the Week 8 Assignments page.

Option #2: Training Presentation

You will assume the role of a training officer or course developer for a local police/military organization. The organization has recently received a grant to develop a special victims' assistance unit, to be staffed by both sworn and civilian personnel. You will develop a presentation to be used as an overview in training unit personnel.

Be sure to read the Portfolio Project description below thoroughly before beginning to work on this option.

Portfolio Project Milestone Deliverables

The following deliverables are due before midnight on Sunday of Weeks 2, 4, and 6:

- Week 2: Topic Submission (10 points of the Portfolio Project)
- Week 4: Annotated Bibliography (20 points of the Portfolio Project)
- Week 6: Portfolio Project Outline (20 points of the Portfolio Project)
- Your presentation must address the following topics:
 - Describe victimology.
 - Provide an overview of the nature of the problem and the roles that police have traditionally taken.
 - Discuss the victimization of various populations, such as the disabled; the elderly; the homeless; immigrants; and lesbian, gay, bisexual, and transgendered (LGBT) people.
 - Discuss culturally based victimization, such as female genital mutilation, rape, sexual abuse, honor killings, gang violence, and crimes against special populations (e.g., the blind, elderly, homeless, and LGBT people).
 - Include details on victim assistance programs.
 - Provide recommendations and strategies to be used by the police department in dealing effectively with victims of crime. Your presentation must contain between 15-20 slides (not including the title and references slides) that will be loaded into VoiceThread. It also must cite a minimum of five peer-reviewed sources, and be formatted per the CSU-Global Guide to Writing & APA. The CSU-Global Library is a great place to find sources! Additionally, you will prepare “speaker notes” to cover the content as if you were presenting this training. You will submit that resource as a Microsoft Word document that also follows APA formatting requirements. Submit the link to your presentation and your speaker notes to the Week 8 Assignments page.
