COURSE DESCRIPTION AND OUTCOMES

COURSE DESCRIPTION:

In this course, students explore the theory, practice, and application of ethics to the field of criminal justice. The course will focus on understanding how ethics works with the practice of criminal justice. This course prepares students for further inquiry into ethics by providing a solid foundation of its role in criminal justice policy and practice.

COURSE OVERVIEW:

This course offers an examination of ethics in criminal justice as a mainstay of professionalism. Students will gain a broad understanding of ethics as an academic discipline and will apply ethical concepts to the practices and policies of criminal justice organizations and professionals. The course will focus on ethical challenges and dilemmas that arise throughout the criminal justice system, providing students with the tools to recognize and address challenges and dilemmas.

COURSE LEARNING OUTCOMES:

1. Evaluate the various theoretical schools of thought as they pertain to ethics.
2. Describe ethical issues faced by criminal justice professionals.
3. Assess the importance of serving the people and maintaining public trust.
4. Analyze various types of misconduct that occur in the criminal justice system.
5. Determine professional strategies for preventing and combating ethical misconduct.
6. Apply ethical standards to criminal justice policies.

Option #1: Example of an Ethical Dilemma

Using concepts from your required readings and one outside source, please respond to the following questions:

- Identify a current ethical dilemma in criminal justice that may affect law enforcement, courts, and corrections.
- What makes this an ethical dilemma? Who is impacted by it?
- What are your suggestions for approaching this dilemma according to deontology, Kantian, or virtue ethics?

Criminal justice for this purpose is a broad term and can encompass any related area, including civil rights, or any aspect of the courts, police, corrections, or community justice.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). Include at least two peer-reviewed scholarly references from the CSU-Global Library, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Option #2: Ethical Perspectives

In Week 1, we have examined various ethical frameworks, including deontology, virtue ethics, and utilitarian perspectives. For this assignment, write a paper where you perform the following:

- First, define ethics, and then compare and contrast each of these three perspectives on ethics.
- Next, select one of these perspectives and apply it to your personal or professional life. Ensure that you fully develop and explain your position.
- Finally, indicate which of these perspectives is the most applicable in contemporary society and indicate why you believe it to be.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). Include at least two peer-reviewed scholarly references from the CSU-Global Library, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Submit Topic and Sources

Option #1: Code of Judicial Conduct

District attorneys are subject to standards and ethics prescribed by their own state code.

Conduct an internet search to locate your state’s code of professional conduct.

Use the concepts from your required readings and the lecture to evaluate the three ethical standards you find most important to the ethical administration of justice in your state’s professional code of conduct.

Evaluate the position that ethical standards, or a particular ethical standard, can hamper the administration of justice. Support your position with reference to concepts provided in the assigned readings and by discussing and citing at least one credible outside source from the CSU-Global Library.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). The CSU-Global Library is a good place to find references.

Option #2: Ethical Standards of Judges

Compare the potential ethical issues of elected judges with those of appointed judges. Then, review the Code of Conduct for United States Judges. Of the five ethical canons listed, which one do you feel is the most important for federal judges to uphold and why?

Support your position with reference to concepts provided in the assigned readings and by discussing and citing at least one credible outside source from the CSU-Global Library.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). The CSU-Global Library is a good place to find references.

Option #1: Ethics of Policy

After reviewing these articles on controversial immigration enforcement and stop and frisk practices by police, address the ethics of policies such as these per the ethical frameworks of deontology, utilitarianism, and virtue ethics. You may pick one or the other, or both, but make sure to clearly explain your thoughts as related to the ethical frameworks.

Support your position with reference to concepts provided in the assigned readings and by discussing and citing at least one credible outside source from the CSU-Global Library.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). Include at least two peer-reviewed scholarly references from the CSU-Global Library, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Option #2: Ethics of Torture

Is torture an ethically sound practice to combat terrorism? Analyze this topic through the ethical frameworks of deontology, utilitarianism, and virtue ethics.

Support your position with reference to concepts provided in the assigned readings and by discussing and citing at least one credible outside source from the CSU-Global Library.

Your paper should be 2-3 pages in length (not including title or reference pages), double spaced, and conform to *CSU-Global Guide to Writing and APA* (including in-text citations and properly formatted references). Include at least two peer-reviewed scholarly references from the CSU-Global Library, in addition to the course textbook. The CSU-Global Library is a good place to find these references.

Choose one of the following two assignments to complete this week. Do not do both assignments. Identify your assignment choice in the title of your submission.

Option #1: The Ethics of Policy

Choose a criminal justice organization or specific agency for which you aspire to work (probation/parole, police agency, corrections, courts, etc.).

Use the CSU Global Library and other credible sources (preferably peer-reviewed) to conduct research on your chosen sector. Based on your research, provide an analysis of at least one current ethical challenge or dilemma in that sector, including why this dilemma/challenge is occurring.

Then, identify a policy that currently exists to address this dilemma. Based on your research, analyze the policy according to the ethical frameworks of deontology, utilitarianism and virtue. Describe the ethical dilemmas presented by the topic and the merits of that policy as it pertains to all stakeholders impacted (i.e., the agency, public safety, the offender, etc.). What are the social, economic, or political influences on this topic?

Next, make recommendations to remedy or minimize the ethical challenges.

In a 6- to 8-page research paper, formatted according to the *CSU-Global Guide to Writing and APA*, present the findings of your research, your analysis of the organization or agency's challenge(s), and recommendations for navigating the issue(s).

Refer to the CSU Global Library for more information on the APA requirements adopted by the University.

This research paper should include the following elements:

- 6-8 pages in length (not including the cover/title page and reference page).
- Cite and discuss a minimum of four peer-reviewed, academic journal articles. You may also want to include other reputable references in addition to the minimum required peer-reviewed sources (information from not-for-profit organizations, etc.).
- In addition to a title page, abstract, and a reference page, the project format should include the following sections, separated by headings/subheadings:
 - **Introduction**—Explanation of the background and context of the ethical issue you have chosen to analyze
 - **Research/Analysis**—analysis of whether the associated policy is adequate and ethical
 - **Recommendations**—what can be done to better address the ethical issue and policy
 - **Conclusion**—brief summary restatement of the above sections

Option #2: The Ethics of Practice

Choose one of the following criminal justice organizations and scenarios.

- You are an Assistant Director at the FBI considering a program that allows cyber-criminal informants to work off their charges by helping the FBI catch other cyber-criminals.
- You are a District Court Judge recommending the creation of a Drug Treatment Court.
- You are the Secretary of Corrections for a state evaluating an early release program to help prevent over-crowding.

With your chosen organization, use the CSU Global Library and other credible sources to conduct research on your chosen scenario. Based on your research, provide an analysis of recommendations to effectively and ethically implement that practice. Based on your research, write a 6- to 8-page memorandum summarizing your recommendations.

Your memorandum, formatted according to the *CSU-Global Guide to Writing and APA*, must include each of the following:

1. Describe the chosen practice in detail. Include a brief history of the use of the practice in other organizations/jurisdictions.
2. What are the ethical questions involved regarding your practice? Ensure that you identify them according to each of the ethical frameworks of deontology, utilitarianism, and virtue ethics.
3. Make a recommendation as to how this practice should be implemented. This will include a specific time frame, including a time line, the clients who will be served (for example, first time offenders only or non-violent offenders), and describe in detail how the program will work, based on evidence-based practice from the literature.
4. Discuss the challenges and possible barriers to implementing this practice.
5. Identify and describe in detail all of the stakeholders affected by this practice.
6. Describe the possible outcomes of implementing this practice.
