Syllabus

Course Overview

Ethical management practices, from both an administrative and patient care perspective, are vital to ensuring integrity and trust during this era of tumultuous change in the U.S. health care system.

Leaders require a working knowledge of how theory and standards, personal values, external market forces, local community, and internal organization factors and challenges guide and influence ethical management decisions, processes, and practices.

This course addresses all of the above and offers application activities and personal reflection to help build a strong ethical foundation for your management career. Throughout the learning units you will create a Course Project Portfolio, which will summarize and synthesize your overall learning experiences and demonstrate your understanding of the applications of ethics to health care management. The portfolio includes an academic case study analysis, an informational interview experience, and the completion of a personal Course Reflection Journal.

A rich variety of resources, materials, and tools are included in your studies to support your work. However, due to the ever-changing landscape of our health care system, the learning unit activities and assignments are specifically designed for application to current realities, whatever they may be. This will require additional research and fact checking to ensure appropriate knowledge and preparation for your career. However, this is a best practice to adopt, as it is required in the role of a successful and ethical health care management professional.

Project Overview

The Course Project Portfolio consists of three components: an Informational Interview Report, an Ethical Case Study Evaluation, and a weekly Course Reflection Journal.

Unit 6: Informational Interview Report

In this course, you will conduct an informational interview with a health care manager in the health care sector of your choosing. The interview offers you an opportunity to obtain an insider's view of current ethical issues presented in the health care field, and to increase your understanding of how managers utilize ethical principles and strategic efforts to prevent and address them. Your assignment in Unit 6 consists of a paper in which you will share and evaluate your experience.

Unit 8: Ethical Case Study Evaluation

In Unit 8, you will evaluate a case study based on a hypothetical scenario involving health care management, patient care, and end of life considerations. You will utilize a formal decision-making process to evaluate this scenario based on the concepts and principles you have studied in this course and perhaps your own personal and career experiences.

Weekly: Course Reflection Journal

Each week, you will reflect back on your most valuable takeaway, identify immediate or future applicability of your learning to your career, and identify what you would like to investigate further. You will also assemble a list of resources and create a personal resource repository for future use in your courses and career.

You will complete one page of your journal for each learning unit and submit it as a graded assignment. When you submit your entry in Unit 10, all of your journal pages will be automatically compiled into one overall journal document.

Unit 1 >> Ethics and Morality

Introduction

Unit 1 of this course addresses how important it is for health care managers to develop an ethical perspective in all aspects of leadership in the health care organization. As you prepare for your career, it is important to build a foundational understanding of the basic ethical theories directly related to health care management. To begin this process, your studies in Unit 1 will introduce you to the works of global and personal ethics theorists and provide examples of practical application in the field. You will listen to management professionals at the National Center for Ethics in Health Care discuss the importance of infusing ethical knowledge and principles throughout an organization to effectively address challenging situations in all aspects of management, leadership, strategic planning and decision making.

In addition, you will explore the relationship between personal value systems and ethical management practice. The concept of moral integrity as a basis for professional actions is introduced, as well as the positive business related outcomes that are derived from it. You will explore personal ethical challenges that might present barriers in maintaining long term, consistent success as a moral leader. In addition, you will have the opportunity to begin reflecting on the formulation of a personal moral compass and ethical bottom line to guide your career. Developing an understanding of this important personal and professional connection at the beginning of the course will prove valuable in working through all of the course material from your own unique, value-based perspective.

Unit 2 >> Ethical Principles

Introduction

Autonomy, beneficence, nonmaleficence and justice are examples of the ethical principles most commonly utilized by health care leaders in organizational management planning, problem solving and decision making. Reflecting back on the work of the ethical theorists discussed in Unit 1, you will easily recognize connections and relationships with these principles. Effective managers refer directly to these ethical principles for preventing and resolving issues related to all aspects of business. The IntegratedEthics model introduced in Unit 1 set the stage for a basic understanding of how every aspect of management in a health care organization can be impacted by ethics-based approaches. In Unit 2, you will build on this foundational awareness.

Ethical principles such as autonomy, beneficence, nonmaleficence, and justice may appear to be relatively easy to define. However, the challenge for health care leaders is in their appropriate application. An effective leader develops knowledge, understanding, and skills in ethical leadership through observation, practice, and reflection on experiences and outcomes. The constant, and often profound, changes in our health care system create continual learning opportunities to develop moral leadership qualities and skills. Each sector of the health care system presents different needs and situations related to each of these ethical principles, although some applications are universal. You will be asked in your work for this unit to think about the path you would like to take in health care management and keep it in mind as you study the concepts and material. This will help to make you efforts more meaningful and relevant to your career goals.

In your studies for Unit 2, you will study each principle individually and reflect on examples of application in sample cases in your readings. You will delve more deeply into the principles of autonomy and justice by viewing thought provoking lectures from leading research scholars in the field of bioethics at the esteemed Kennedy Institute of Ethics, as well as listening to the National Center for Ethics in Health Care Voices of Integrity audio for the week. The coursework for the unit is designed to assist you in developing a strong understanding of the valuable role these important ethical principles play in health care management and in your future career with your degree.

u02d2 - Applying the Principle of Justice

As you have learned in your studies for Unit 2, there are many aspects of the ethical principle of justice that must be recognized and successfully dealt with in health care management. You saw examples and perspectives on applying the principle of justice in leadership practice in areas of patient justice, staff justice, and market justice. You also considered the principle of distributive justice.

Select and describe a health care management position in any area of the health care system. It can be a sector in which you have experience, or one you would like to enter or further explore (for instance, for-profit, nonprofit, government or regulatory agency, large insurance organization, small private entity, specific department, et cetera).

- · Identify and discuss one area of justice as it might apply to the duties and responsibilities of those in management in that specific setting.
- Describe an example of a potential ethical issue and recommend actions for proactive prevention as well as resolution after the fact.
- Connect your ideas back to the ethical theories studied in Unit 1.
- Directly refer to your studies and outside research in your writing to help explain and back up your personal ideas, insights, and opinions.

Unit 3 >> Government and Market Forces

Introduction

In previous units, you studied the major theorists and fundamental ethical concepts related to health care issues, and you were introduced to the important role this knowledge plays in effective health care management. Unit 3 moves on to the section of the course that examines the external forces affecting the health care industry and health care management. You will discover how this foundational knowledge is considered and applied in strategic planning and decision making to prevent, address, and resolve possible ethical issues.

External market forces present a tremendous challenge to a health care manager. Any changes in society connected to demographics, the government, economics, politics, legislation, and even weather affect the health care industry. This is true on global, national, state, and local levels. Therefore, an effective manager must keep abreast of current issues and simultaneously attempt to accurately forecast and prepare for future change. To begin your study of the various market forces that challenge health care ethics, Unit 3 specifically addresses: managed care, the change in demographics due to the aging of the baby boomers, and the growing public interest in and demand for integrative medicine alternatives and options in care. You will investigate and analyze one of these market forces in detail.

In addition, your studies and discussion work in Unit 3 include preparation for conducting your informational interview with a health care manager, which will be conducted in Unit 4. Careful attention to this preparation process is vital to overall success in the course, as the findings from your interview provide context and content for the first section of your Course Project Portfolio, the Informational Interview Report, due in Unit 6. Please refer to the Course Project Portfolio description to review the full project.

Your informational interview can be described as an informal conversation with a health care manager who is willing to share personal and professional expertise, knowledge, and perspective on ethical challenges. Your goal is to obtain an insider's view of current ethical issues presented in the health care field, and to increase your understanding of how managers utilize ethical principles and strategic efforts to prevent and address them. To enhance the personal value of this experience, it is recommended that you choose a manager in the specific sector of the health care industry you would like to pursue in your career. The professional might manage an organization, facility, department, or team.

Unit 4 >> External Influences of the Community

Introduction

In Unit 4, you will continue to study forces affecting the health care industry and health care management. The concentration in this unit is on influences related to the community. Your studies introduce the concepts of stewardship and fiduciary duty as they relate to ethical health care organizational management.

Your studies for this unit introduce you to an overwhelming array of both mandatory and non-mandatory regulatory agencies and organizations that control the health care system. The organizations can be national, state, or local, and include consumer advocacy organizations, as well. They exist as external entities to protect the community and limit the power of the industry in various ways. Health care managers have a responsibility to understand, remain updated on, and assure compliance with specific guidelines and regulations in their sector of the industry, in order to remain in compliance and uphold an outstanding reputation for themselves and their organization. Strategic planning, development, and implementation of policies and procedures, training of staff, and building strong organizational cultures support this compliance. They also present internal opportunities for effective leaders to model stewardship and fiduciary duty toward the community.

In addition, successful health care managers model stewardship and fiduciary duty by reaching outward to serve as advocates for their organizations and profession. Active participation in professional organizations is recommended as a strategy to build personal and organizational trust and integrity in the community. The concept of corporate social responsibility (CSR), based on the triple bottom line concept of business management, is embraced by many health care organizations. The ethical perspectives of CSR support health care manager efforts in the development of positive connections and partnerships in the community. This creates social value and is a demonstration of stewardship and fiduciary duty. This could translate locally, nationally, or globally, depending on the type of health care organization involved.

Unit 5 >> Organizational Influence and Ethical Decision-Making Processes

Introduction

With the completion of the previous unit studies on external forces, your studies now turn to the internal organizational forces related to ethical health care management. Unit 5 examines the organizational influence of finance. As Morrison (2016) states, "Even in the best of times, the demand for healthcare often exceeds the financial and provider resources available, especially in the case of the uninsured and underinsured" (p. 192). It can be said that one of the most profound organizational influence challenges for health care managers is that of balancing stewardship and fiscal responsibility. In this unit, you will explore conflicts of interest, billing practices, fraud, and abuse as examples of ethical issues related to the organizational influence of finance. You will discover how the concept of justice plays a central role in ethical finance decision making and management. As leaders attempt to balance priorities related to market justice and patient justice, they must still continue to consider and protect the justice of their staff and community in the process.

Unit 5 also introduces the value of utilizing formal ethical decision-making processes for managing ethical issues within the health care organization and why they differ from business processes in other industries. You will discover how developing an ethical mindset, adopting a personal moral stance, and choosing a personal ethical philosophy are vital for building a strong foundation on which to utilize these formal decision-making processes and steps. Common errors, or decision traps, often occur in decision-making processes and impede success. You will identify and personally reflect on various decision traps that will support the development of your own ethical decision-making skills and awareness.

Unit 6 >> Organizational Culture

Introduction

Unit 6 covers the many ways that cultural concepts act as powerful forces in ethical health care management.

The ACHE (2015) states, "The number and significance of challenges facing healthcare organizations are unprecedented. Growing financial pressures, rising public and payor expectations, consolidations and mergers, patient safety and quality improvement issues and healthcare reform have placed healthcare organizations under great stress—thus potentially intensifying ethics concerns and conflicts. Healthcare organizations must be led and managed with integrity and consistent adherence to organizational values, professional and ethical standards" (para. 1).

Your coursework focuses on the importance of creating a strong, ethically oriented organizational culture to support leader success in meeting these challenges with integrity. The role the health care manager plays in implementing policy and procedures as well as modeling an ethical mindset and behavior are discussed. You will also study interesting examples regarding the concept of storytelling as an effective management tool to help define and develop an organizational culture.

Assignment Components

To begin your paper, identify and describe the sector of the health care industry you have chosen to explore. Describe the organization, facility, or department chosen, its stated mission and goals, and provide context regarding the community or population it serves.

Introduce your interviewee. Briefly describe the background that brought this person to his or her current position. Explain the description and expectations of this person's management role. Include information the professional shared regarding how personal moral values, membership in professional organizations, and continuing education guide and support personal efforts in ethical management practice.

Describe an ethical challenge experienced by your interviewee in his or her organization, facility, or department, and analyze the approach taken to resolve it. If there is not a detailed example of a problem available, base your work on measures taken to prevent a specific major ethical issue, and analyze why the current approach is successful.

Discuss and evaluate the information gathered regarding the ethical problem. Include the following:

- · Describe how formal policies, processes, teams, and individuals were utilized in addressing or proactively avoiding the ethical problem.
- Identify and explain the influence and role of external regulatory policies, and regulations in addressing or preventing the ethical issue (such as Joint Commission, HIPAA, et cetera).
- · Describe how specific external forces influenced the resolution or prevention of the ethical issue.
- · Describe how internal organizational factors influenced the resolution of the ethical issue.
- · Identify and apply the ethical principles and theories related to the ethical issue and the management approach taken.

Conclude your paper by sharing personal insights gained from the informational interview experience. Identify tools, knowledge, skills, or awareness gained for use and success in your personal ethical management practice.

Unit 7 >> Ethical Operations Management Technology and Data

Introduction

"Healthcare operations management covers a wide range of activities and the healthcare personnel charge to manage, perform, monitor, and evaluate these activities are expected to adhere to ethical principles and ensure that the activities fit with the organization's mission, vision, and values" (Forrestal & Cellucci, p. 202).

Unit 7 explores the role and requirements related to the practice of ethical health care operations management. You will investigate laws and regulations, strategic planning, and consequences related to quality assurance efforts by applying ethical principles to hypothetical and real-life case studies. The focus of your work will be related to ethical issues involving technology and data.

Organizations, such as the Joint Commission and the National Committee for Quality Assurance, collect and report extensive data on quality indicators utilized by the industry, government, and consumers. The Health Insurance Portability and Accountability Act (HIPAA), passed by Congress in 1996, protects the privacy and confidentiality of patient health records. The Office for Civil Rights (OCR) of the U.S. Department of Health & Human Services oversees this compliance and offers comprehensive support and guidance for health care leaders and organizations.

The use of health information technology and electronic health records continues to improve quality of care indicators and offer ever-expanding career opportunities in the health care field. However, current knowledge of rapid advancements in technology (for both management and clinical applications), along with their ethical implications, demand increased time and attention from health care operations managers. The consequences of data security breaches can be detrimental in legal costs and loss of reputation and trust within the industry and community. Unit 8 >> Ethics and Patient-Centered Care

Introduction

Unit 8 takes a historical journey through the transformation of the patriarchal health care system to the currently emerging patient-centered care model in the United States. The patient cultural revolution, boosted by technological advances and increased access to health-related information, presents tremendous change and managerial challenges throughout the entire health care system. These changes affect direct patient care facilities as well as the organizations and administrative departments related to, and supporting, their efforts. The patient-centered care model has increased the need for a solid leadership understanding of the patient experience and an enhanced ability to measure, interpret, and report it accurately. Ethical challenges related to patient-centered care present additional considerations to the existing managerial task of balancing quality care and fiscal responsibility.

Unit 8 emphasizes patient-centered care models, such as Planetree. However, many of the resources included in previous units are applicable to your work related to ethics and patient-centered care: the IntegratedEthics model, the Voices of Integrity audios, the Kennedy Institute of Ethics, the Joint Commission, the American College of Healthcare Executives (ACHE), et cetera. Be sure to consider researching organizations specifically related to your chosen career sector of the health care system.

In addition to one discussion topic and your Unit 8 Course Reflection Journal entry, the second component of your Course Project Portfolio, the Ethical Case Study Evaluation, is due this week. The case study involves a hypothetical scenario involving health care management, patient care and end of life considerations. You will be evaluating this scenario based on the concepts and principles you have studied in this course and perhaps your own personal and career experiences.

Unit 9 >> Health Care Codes of Ethics

Introduction

Unit 9 provides an in-depth examination of health care codes of ethics. Your Unit 9 coursework will directly involve researching, evaluating, and applying codes of ethics and the ethical principles on which they are based.

Professionals in all aspects of the health care industry are guided by specific codes of ethics. The American College of Healthcare Executives (ACHE), the Medical Group Management Association-American College of Medical Practice Executives (MGMA-ACMPE), and the American College of Health Care Administrators (ACHCA) provide codes of ethics for health care management professionals.

Oftentimes, a clinical professional is serving in an administrative or management role and is considered bicodal. Two professional codes of ethics might be applicable and relevant to his or her career choices and decisions. The basic ethical principles in both codes of ethics will be consistent. However, management ethical codes specifically include fidelity, stewardship of resources, and implementation of policies that affect the organization, staff, and the community.

It is beneficial for health care managers to be aware of the codes of ethics of all of the professionals within their facility, organization, or department. Depending on the type and size of the organization, this can present a formidable and challenging task. However, the increased knowledge and awareness resulting from this effort directly support managerial success. Understanding the unique interpretation of the application of ethical principles for different disciplines within an organization assists a manager in facilitating effective communication, building an ethical organizational culture, and creating culturally diverse and competent health care teams and ethics committees.

As Forrestal and Cellucci (2016) state, "A call had been made to create a unified, transdisciplinary code of ethics for all healthcare professionals, to get everyone on the 'same page'. Such a code of ethics would be adopted across all healthcare professional disciplines. Although a transdisciplinary code has yet to be adopted, the similarities among disparate codes can serve as a starting point for such a universal code (p. 71)". Consider that the increased learning and awareness you gain though your studies and coursework in Unit 9 will serve as an industry driver to help facilitate movement in this forward direction. It is certainly possible that you will be affected, if not personally involved, in this evolutionary change during your health care management career.

The ACHE (2013) predicts an exciting and wide open career path: "As new patient care delivery models emerge, traditional career ladders are giving way to new paths in healthcare that include all aspects of the healthcare continuum. An ongoing commitment to growth prepares healthcare executives for the resulting career opportunities" (para. 2).
