Course Overview

In this course, you will examine the complex and dynamic U.S. health care system, as well as the laws and regulations that affect the health care system and stakeholders. From this baseline, you will gain a greater understanding of how health care delivery systems are organized and the financial and economic, legal, and political factors that influence the management of health care organizations. All of these elements become a matrix from which health care decisions are made.

u01s1 - Course Project: Feasibility Study

A feasibility study in health care is part of a strategic plan designed to examine a need, or perceived need, within a health care organization. It is the process of investigating and analyzing the viability of an idea and answering a broad range of questions. For decision makers, it is an essential element to prevent the wrong decision from being made, or to validate that the idea being studied is the right choice to make.

Project Context

The feasibility study you will develop as the course project has been modified to fit into the 10 weeks of the course. Each week you will be instructed to work on a specific piece of the study. If you do not work on the study each week, you may find that you will be hard-pressed to complete and submit each assignment when it is due.

For your feasibility study, you may draw upon an actual experience in your current workplace, or use the case study provided. If you choose to develop a study based on your actual work situation, please be certain that:

- You have talked to your supervisor, manager, or director to determine if the policies of your organization allow for the use of internal proprietary information.
- You have access to the data you will need to complete the study.
- The "Organization Background" section of the study provides enough information for a reader to understand the nature and complexity of your organization.

Many learners are employed by large, complex health systems; these cautions are provided to make sure you can meet the requirements of the course project.

If you choose your own workplace, please pick one of the following options to base your feasibility study on. If you want to use a different situation, please contact your instructor. You have been asked by the CEO of your organization to develop a feasibility study for one of the following:

- To address a market opportunity.
- To mediate a systemic problem.
- To address an issue in quality.

If you prefer, you may choose to develop a feasibility study using the following case study:

Although the case study is dated 2006, health care organizations—large and small—still face the issues presented in the study. The health care landscape changes frequently with bankruptcy, and consolidations are a very frequent occurrence.

Discussion Instructions

As a current or future health care professional, your daily interactions will be with the system at large at many levels. This activity begins a process that spans the duration of this concentration. No matter your position in leadership, your interaction in health care is not linear. It requires working in a system.

As you think about and examine your current or potential future role in health care leadership:

- Identify clearly your role in the organization.
- Include the elements of the health system that affect your role.
- Rank these elements as having:
 - Immediate effect.
 - Short-term effect.
 - Long-term effect.
- Create a diagram that illustrates the interaction of these elements. (You may use Visio or the visual tools in Word to do this.)
- Explain briefly your view of the system. Within your explanation, include:
 - Your role in the system.
 - How this system affects your daily work responsibilities.
 - An example of a shift in one element of the system and how that shift might affect the whole system.

Remember that any time you support your statements with references, you must cite your sources following current APA guidelines.

Response Guidelines

After posting your discussion, respond to at least two other learners. Have they described the system clearly? How does the system they described compare to yours? Do you have any questions about their system?

Option C: Internal Quality Management Team

The CEO of your health care organization is working with the CFO to enhance and expand the skilled nursing facility's quality management team. You must identify the partners who would be essential in this expansion.

Option D: Policy Advocacy

You have been asked by the leadership of a professional organization, of which you are a member, to spearhead a policy change within the organization that will affect your scope of practice. You must identify the partners who are essential to advancing the policy process.

Example assignment: You may use the assignment example, linked in the Resources, to give you an idea of what a Proficient or higher rating on the scoring guide would look like.

Requirements

Develop a business report for the option you selected. In the report:

- Analyze the relationships within a health care system that are necessary to achieve an organizational goal.

Introduction

This portfolio work project will demonstrate your ability to think critically about the relationships between the health care system and the decisions that leaders make.

Scenario

You have been asked by the CEO of your organization to propose a project to address a specific need, and to develop a feasibility study to determine if the proposed project should be undertaken.

Your Role

You are a department leader in the organization.

Example assignment: You may use the assignment example, linked in the Resources, to give you an idea of what a Proficient or higher rating on the scoring guide would look like.

Requirements

Complete each section of the feasibility study as completely as possible, and support with relevant evidence. The length of your feasibility study will depend largely on the project or program you are proposing to address the need of your organization. Be sure that each section is fully addressed.

Your feasibility study should:

- Provide relevant information on the organization (Section I).
- Analyze the objectives of the proposed program (Section II).
 - Explain why you are proposing the program.
 - What systems issues will it address?
 - What systems will be affected by it?
 - Where does it fit within the organization?
 - Explain how both patients and the organization will benefit from implementing the proposed program.
 - Provide evidence that the program is needed.
- Explain the value of the program (Section III).
 - How well does it align to the organization's mission?
 - How well does it fit with existing programs and services?
 - Do competitors offer something similar? If so, how will your program give your organization a competitive advantage?
- Analyze the potential financial and economic issues of implementing the program (Section IV).
 - Identify any economic issues that could affect the success of the program.
 - Explain how your program could affect the local economy (both positively and negatively).
 - Identify possible funding sources.
 - Estimate the cost of implementing and maintaining your program.

- Analyze the marketing issues associated with your program (Section V).
 - Explain how your program may affect the existing marketing approach.
 - Explain how your program will meet the needs of the target market demographic.
 - Explain how you will differentiate your program from those of competitors.
- Determine how the program may affect the entire organization (Section VI).
 - Are there regulatory or policy implications?
 - Will new licenses or certificates be required for the organization or staff members?
 - Will the program affect the tax status of the organization?
 - How might the program affect liability and risk management?
 - Do you have enough space for the program?
 - Do you have evidence to support the effectiveness of the program?
- Recommend a course of action based on the information in the feasibility study.
 - How does your recommendation reflect ethical decision making?

Deliverable Format

The feasibility study is a professional document and should therefore follow the corresponding MBA Academic and Professional Document Guidelines, including single-spaced paragraphs.

Organize your document using this structure:

- Title page. (What is the title of your proposed program?)
- Executive summary. (Many executives require an executive summary for projects of this type. The summary is written last, but becomes the first section of the feasibility study and provides an overview of the goals and objectives, summarizes the key points supporting the need, summarizes the key points supporting your proposed program, and includes your conclusion and recommendations.)
- Feasibility study.
- References page.
 - APA-formatted references.
- Written using language appropriate for an executive audience.
