## **Syllabus**

#### **Course Overview**

This course examines the structure and operations of the public health system and reviews the administrative processes that foster integration and managerial effectiveness within and among public health organizations and programs. The course provides an overview of human and financial resource management, technological systems development and integration, legal and ethical issues, the application of performance indicators, and basic principles of leadership, governance, and management.

## **Public Health Leaders**

Public health leaders have an abiding interest in health status improvement, quality of care, and cost-effective services. They need to understand the nature of systems and how they function in a society holding diverse values and common or diverse interests. A leader also must appreciate the importance of negotiation, systems thinking and analysis, and basic principles of leadership, governance, and management, including methods and techniques for creating a vision, empowering others, fostering collaboration, and guiding decision making.

This course provides guidelines for development of collaborative partnerships and shared visions for achievement of public health mission and goals.

## Unit 1 >> Public Health Systems Evolution and Foundations

#### Introduction

The dual overriding contrasts of the value-driven mission of public health organizations and the pressing conditions of health disparities and gaps that unfortunately persist throughout the nation continue to be significant issues in the United States today.

Public health provides services to protect, maintain, and improve the health status of populations. The public health system comprises programs and services provided by federal, state, and local governments.

## Mission and Vision of Public Health

The Institute of Medicine (2014) defines public health as that function fulfilling society's interest in assuring the conditions in which people can be healthy. The aim of public health is to generate organized community efforts to address the public interest and health by applying scientific and technological knowledge to prevent disease and promote health. The vision of public health is addressed by a combination of public and private organizations and individual groups.

# Required

## Personal Research

Your first major assignment, Public Health System Resources, is due in Unit 3. You are advised to begin research for that assignment this week. For this assignment, you will have the choice of using the data from the state of Nevada's DHHS, or a community of your choice, as the basis to identify a disadvantaged, diverse population and a community-based health issue affecting that population. Whichever option you choose, be sure that your area of focus is at a local level, in order to be able to better examine the specific factors that contribute to the issue. In other words, look at the municipal or neighborhood level (depending on how specific your data is) rather than the state level.

Note that many of your course activities will be an accumulation of examinations and reflections regarding your selected population and issue, so your selections should sustain your interest throughout the course.

# Preparation

Once again, review the state data provided on the Trust for America's Health website, titled States in Detail, linked in the Resources. Select one health issue, such as obesity or substance abuse, and examine how your selected state's incidence of those conditions compares to national rates and to at least one neighboring state.

• Review where your state stands on your chosen issue, review the data for your state regarding disparities, and provide a summary of any patterns you detect.

## **Discussion Post**

For your initial post in this discussion, do the following:

- Examine the facts regarding observed health disparities in your selected state in regard to one health condition that you believe to be of significant concern, and make a comparison to other states.
- Speculate as to the causes of these disparities. Using the Trust for America's data and other data sources you find, explain at least
  two possible causes for the disparities you have found. Suggest at least one approach to assessing health risks for individuals in your
  state to address a significant disparity.
- Support your answers by citing references from your text and assigned articles or from scholarly literature and share relevant insights
  from your professional practice. Use correct APA formatting for all references and in-text citations.

# Response Guidelines

Read the posts of your peers and, in a substantive response, address the following. Please respond to posts that have had few responses thus far and refer to the discussion response guidelines in the Faculty Expectations Message.

• Engage your peer and explain specifically why you chose to respond to this post.

• Find one pertinent peer-reviewed article in the Capella library and briefly introduce the article. (Is the information in the article based on a study, a literature review, and so on?) Paraphrase the relevant parts of the article in your response.

In your reply, try to balance your own professional experiences with an academic perspective, based on your peer-reviewed article. When you support your comments with details from your personal experience, workplace, or familiar health care setting, you are not required to cite a source. However, if you offer an alternative viewpoint or reference the ideas or work of others, you must include a properly cited scholarly source to support your assertions.

#### Unit 2 >> Evolution of Health Services in the United States

# u02d1 - Community Engagement

## Overview

A significant number of the problems that affect the health and welfare of people in communities cannot be solved by any individual, organization, or group working alone. Collaborative effort on the part of key stakeholder groups, working together in a process designed to maximize effective community engagement, is more likely to be successful than independent initiatives. All health care professionals, but especially public health professionals, will need to develop competence in engaging the community to help drive positive outcomes for the populations they serve.

For this discussion, reflect on personal and professional experiences you have had in which you needed or attempted to engage the community. In your initial post address the following:

- · Explain an experience in which you engaged the community as part of a personal or professional project.
  - What was the project and its goals?
  - Why was community engagement a necessary component of attempting to achieve the project's goals?

    - What successes or challenges did you encounter in your engagement efforts?

#### Unit 3 >> Health Organizations

#### Introduction

The public health system in the United States is the most sophisticated and most expensive in the world. Yet, the current system has definite shortcomings.

The system is a complex network of fee-for-service reimbursement, managed care, employer-sponsored coverage, and federal- and state-funded programs. For individuals with private health care coverage, accessing health care is much easier than for populations who rely on state or federal health programs.

Addressing the shortcomings in the system requires an understanding of the current structure of health care resources and the public health implications of this structure for the population. This unit will focus on the structure and organization of this system.

#### u03a1 - Public Health System Resources

## Overview

In this assignment, you will create a public health system resource document. It will contain key information needed to create a plan of action for a collaborative public health outreach initiative in a local community. This type of document is something you (and others) could use as an on-the-job resource. A public health system resource document helps you to keep track of possible local organizations, people, or entities that could support your health issues now or in the future. In fact, keeping an active public health system resource document allows you to add new possible public health system resources as new stakeholders enter the field. Because collaboration with people and agencies is key to supporting your health initiatives, it is important to organize community people and organizations that might be able to support your ongoing needs for public health in your community.

You have the choice of using the data from the state of Nevada's DHHS, or a community of your choice, as the basis to identify a disadvantaged, diverse population and a community-based health issue affecting that population. The important thing is that you can research data specific to the community and issue you are seeking to address. Keep in mind that an on-the-job resource will be more relevant if you focus the scope of your research and work on a specific county, city, or area served by your current place of practice. In other words, it is inadvisable to try to research and address this issue at a state level or higher.

Format your document based on your own needs. You could create a table in Excel or in a Word document—choose a format that works for you and your professional setting.

**Note**: Think broadly, beyond the academic setting. Create as if your coworkers will find this a great resource. If the way in which you format this document is something you think provides an advantage over other types of documents, make a note to your instructor about why you selected that style and how the format will make it easier for others to use.

#### Real-World Scenario

Using your selected population and community-based health issue as a focus, imagine that you are tasked to assemble such a resource as described above. You will present it to your supervisor, who will ultimately distribute it to a public health team for review. In this type of real-world scenario, you are expected to create a one-page memo or e-mail to your workplace supervisor. It will summarize the result of your work and any recommendations for what will be valuable to the team.

You will be graded on how well you accomplish the following:

- Use appropriate public health resources to obtain current data about a public health issue in a specific community or locale.
- Identify local and national public health organizations currently addressing a specific health issue.
- Describe systems thinking tools that could prove useful in addressing a public health issue.
- Describe how public and private partnerships work together to address a specific public health issue.
- · Address all components of the prompt and use the assignment description to structure text.
- · Apply APA formatting to in-text citations and references.

#### Instructions

Complete the following:

- Focus on finding system resources related to the health issue you are studying.
- Create a separate 2–3 page table of health problem data, resources, and players in the world of public health related to your issue.
- Summarize your findings and your determination of the value of those findings in a one-page memo or e-mail addressed to a workplace supervisor.

#### Step 1: Data Gathering

Use the Capella library and the Internet to gather this information. A number of excellent resources are already provided in your studies.

You will need to collect data related to the following categories:

- Place and Organization: The community of interest and the host organization.
- Health Issue of Concern: A disease or injurious situation.

- **Demographics**: Populations affected and incidence or prevalence trends.
- Resources: Data on health professionals, institutions, and funding.
- Stakeholder Groups: Listing of key resources and advocacy groups.

Create a document that is designed to be used by your coworkers as a resource.

Step 2: Memo

Summarize your findings in a memo to a workplace supervisor. You are encouraged to use the style and format of a professional memo from your workplace for this document. If you are not working at this time, find an example of a professional memo on the Internet and use that as your format guide.

Your memo should summarize what you have found and how your organization could best use that information. Include the application of systems tools for taking advantage of resources that exist related to the identified health issue and the potential for interagency collaboration.

# Additional Requirements

- Length: Two documents:
  - A 2-3 page table of data.
  - Memo: One double-spaced page in length, not including title and reference pages.
- Font: Times New Roman 12-point.
- References: Create a full reference list of the resources listed in your table. Format your list according to APA style. Include
  hyperlinks to external sources.

## Overview

Throughout this course, you have been exposed to competencies and skill sets that are required in public health. This assignment provides you an opportunity to showcase your talents in a Kaltura job interview video that strategically aligns your skills and talents to the content of the selected job description.

## Scenario

Imagine you are a graduate now with a master's degree in public health. You have applied for a job with the Department of Health and Human Services in Carson City, Nevada. You have submitted materials including a cover letter and résumé for the job of Division Administrator, Division of Public and Behavioral Health. You have been contacted by a human resources liaison, who explained more about the job description and confirmed your job history. This information was sent to the Deputy Director of Administrative Services and the screening committee. After reviewing your educational achievements and employment history, members of the department have invited you to the next screening step—the recorded interview.

The human resources liaison has already briefed the committee on your résumé, which included a detailed description of your employment history, scope of responsibility, reasons for leaving, salary history, and professional references. Each of your professional references has been contacted and their input has been provided to the committee.

Because the committee already knows the information in your cover letter and résumé, you do not need to report on your job history. You may, however, use the video to provide examples of how you addressed different issues from what the department members are seeking.

#### u08d1 - Immunization Policies

The purpose of this discussion is to explore the role of advocacy in addressing public health issues.

## Overview

Successfully addressing public health issues may be more difficult if effective approaches conflict with existing health care policy. For example, there has been credible research to support the palliative properties of marijuana for some medical conditions, but until recently, marijuana was an illegal substance in the United States. Policy changes—and political changes—were required to make it available for patients, and this required significant advocacy efforts in several states.

# **Discussion Post**

Some aspects of advocacy initiatives conflict with current health care policy. To what extent do you think the government should be empowered to ensure that all schoolchildren are immunized against measles?

For your initial post in this discussion, make the case for whichever stance you would take.

- Define your viewpoint on immunization and describe the policy approach you have in mind, explaining how it would support the ability
  of the community to prevent the spread of disease.

# Overview

Essential features of a case study include the following:

- **Nature of the Problem**: Statement of the issue of concern, disparities in outreach services to be addressed, and significance of the problem.
- Stakeholders and Stakeholder Groups: Concerned organizations and groups. Include the dominant values and interests of stakeholders and the common concerns and visions of stakeholders.

- Alternative Solutions: The primary (2–3) interventions surfacing as candidates for change. Include the strengths and weaknesses of criteria for judging priorities.
- **Primary Optimal Solution**: Essential programmatic and practice elements that could lead to success. Is there a replication of study in other communities?
- **Reflection**: The advantages and disadvantages facing potential initiatives designed to develop, implement, or assess the proposed solution.

## Instructions

Develop a case study analysis that addresses issues and problems related to public health multiagency collaborative initiatives. These initiatives should improve outreach efforts addressing health equity and related issues of system efficacy, quality, and effectiveness.

Your case study analysis will be graded on how well you demonstrate the following:

- · Describe alternative solutions and interventions as candidates for adoption.
- · Describe performance indicators for judging priorities.
- Discuss how a mission or vision statement was (or could have been) used to empower stakeholders.
- Describe practices that foster collaboration and decision making between diverse stakeholders.
- Describe how specific systems thinking tools can be used to accomplish a public health program's goals and objectives.
- Support main points, assertions, arguments, conclusions, or recommendations with relevant and credible evidence.
- Apply APA formatting to in-text citations and references.

- Font: Times New Roman 12-point.
- References: At least six references that are in addition to your textbook.
