

# **Managerial Accounting**

## **Course Description:**

An introduction to the accounting requirements necessary in a management environment. Topics include the concept of risk, budgeting and variance analysis, costing of products, debt management and working capital management. Students use computers in order to become comfortable with these tools.

## **Course Objectives:**

Financial accounting involves reporting results of past economic activities for an entity. Students gained an understanding of how to record economic transactions in a standardized consistent manner. Standards and consistency are critical to allow comparison among organizations. In contrast, managers may compile information in any manner that provides value for decision making. Students will learn that data not only comes from financial records of the company, but also from other sources such as marketing, engineering and production. Students will gain appreciation for identifying problems and solutions through creative analysis.

## **Student Outcomes:**

At the completion of the course students are able to:

- 1. Explain the difference between financial and managerial accounting
- 2. Describe cost concepts and appropriately classify costs and expenses
- 3. Compute breakeven analysis

- 4. Develop operating budgets, prepare flexible budgets and analyze performance
- 5. Identify relevant data for decision making and perform appropriate analysis

## **Homework and LearnSmart:**

Two types of homework will be assigned for the class – LearnSmart homework and End of Chapter problems and exercises. Assignments and LearnSmart will make up 30% of your grade. End of chapter problems and exercises must be completed by the date and time noted in CONNECT. The system will automatically submit the assignment at its due date, even if incomplete. No late homework assignments will be accepted. The use of any third party answer keys or solution manuals is also unacceptable.

## **LearnSmart:**

The Learnsmart modules are graded based on how much of the module you complete. If you completed the entire module, your grade is 100% for that assignment. Note that it is your responsibility to make sure the module is complete by checking the status report after the module terminates. Assignments must be submitted by the start of the class on the due date. No exceptions! You will receive a 0 for any late submissions.

Since LearnSmart does not require reading the entire chapter in the initial assignment, students are encouraged to read the entire chapter after completing the LearnSmart assignment to ensure mastery of all the components of the chapter.

## **End of Chapter homework:**

Homework completed in Connect will be graded and assigned a percentage grade. Your homework will be completed using Connect, a program found on a web site maintained by the publisher of the textbook.

Each student will be required to complete homework on a weekly basis. All homework should be completed in accordance with stated deadlines. **Any late assignments will receive a grade of 0, no exceptions!** Each chapter should require approximately six hours or more of study time.

Before beginning your homework you must register for Connect using the web site provided by your professor. The assignments in Connect will match up with the numbers in your textbook. It might be wise to complete the homework on paper, and then enter your information into the web site.

<u>SPECIAL NOTE</u>: as you are working problems you can check if you are correct before final grading by clicking on the "Check My Work" button at the bottom of the screen. You may do this as many times as you like.

There will be quizzes which will be located in the Connect software. These quizzes will consist of multiple choice questions and will be timed. These quizzes should help prepare you for the exams and will be graded and become a portion of your final grade.

## **Case Projects:**

This exercise will require you to use Excel and show your skills and knowledge of spreadsheets and the many uses of Excel. The Exercise is Integration Exercise 9 (Master Budgeting) This project will provide an opportunity to apply the concepts in a comprehensive format. #### **Discussions:**

The Weekly Discussion question is a required part of this course. The participation and activity is evaluated based on relevance and contribution to a topic. In an effort to have students gain new perspective, questions are encouraged. Healthy, constructive debate of concepts is a positive interaction.

All students are expected to contribute weekly to the Canvas discussion question. This activity will count towards the participation grade component of the class. Each student is required to respond to a **minimum of two** fellow classmate's discussion posting. <u>Due dates are posted in Canvas</u>. Responses should be respectful, constructive, and engage the class in thought provoking discussions.
