

Chapter Quizzes

There will be four case studies. Case studies will apply management concepts to various sport organizations and situations. These case studies will require outside reading and research. More details can be found in Blackboard.

Discussions Forums

Discussions are a vital part of any online class and require active involvement from all students. These forums take the place of face-to-face dialogue. While I would like to see lively discussions and healthy debates, please keep your posts and responses professional and courteous to your fellow students. Personal attacks will not be accepted and any students writing them will be removed from the course.

A minimum of FIVE posts are required for the week.

Initial posts are due on Friday, all responses to classmates are due on the following Monday. Please do not expect full credit if posts are all made in the last hour. This does not allow for correspondence from classmates.

You will receive a ZERO for the entire discussion if your initial post is not posted by Thursday.

All initial discussion postings should be formal short essays reflecting articulate thoughts and critical thinking theory. They should be 'substantive' in nature. Personal opinions are acceptable to discussion questions; however, they must be supported with sources.

You must provide at least one reference for each initial post when requested.

All **responses** to classmates, posts do not have to be long, however they must convey that you read their post and address specific material in there post. You will not get credit for simply saying 'Good post, I agree with you'.

- (5 points) Clearly spent time with the material; provided additional thoughts/comments relative to sport management; brought additional dimension(s) to the discussion beyond what the questions asked; additional research and references/citations are provided (if appropriate for the discussion question); demonstrates a desire to learn and enjoys intellectual exchange. Frequent visitation (both reading and responding) to the overall discussion occurs throughout the entire time frame.
- (4 points) Appears to have read the material and contributed thoughtful insights to the questions asked; demonstrated a positive interaction with peers; demonstrated an interest in expanding the current knowledge base; additional research and references/citations are provided (if appropriate). Frequent visitation (both reading and responding) to the overall discussion occurs throughout the entire time frame.
- (3 points) Appears to have read the material and answered the questions posed; provides the minimal required posts; responds to classmates. Does not bring any additional dimension(s) to the discussion. Visits the discussion occasionally throughout the time frame.
- (2-1 points) An adequate response to the specific questions posed in the discussion summary; demonstrates evidence that the material was read; entered the discussion but did not contribute personal insight or enhance the exchange between classmates.

Infrequent visitation (reading and/or responding) occurs during the discussion's time frame. Example – only contributes to the discussion on the last two days.

Per the Coker University 2020-2021 Student Handbook:
