Academic Honesty: All work that is submitted should be your own work. Cheating or plagiarism will not be tolerated. Any instance of cheating or plagiarism, including but not limited to turning in work that is not your own, submitting work that is completed with unauthorized assistance, helping someone else commit an act of academic dishonesty, lying about work or absences, inventing false information or citations, etc. Appropriate consequences will be determined by the instructor after meeting with the student.

Academic Expectation: Intellectual honesty and integrity are the cornerstones of Coker University's educational mission. Student academic work is expected to unquestionably represent the student's own thoughts and words. Students must thoroughly and appropriately acknowledge sources for words or ideas that have been generated by others. It is each student's responsibility to be familiar with appropriate citation techniques and to acknowledge the intellectual and creative contributions of others in all academic work done at the University.

Attendance Policy: Class meeting attendance and participation is necessary for academic success. How can you learn if you do not attend the meetings? It is imperative that everyone arrives on time to each and every meeting to realize the full benefit of the course. Synchronous meetings will be held every other week. Students are to follow the guidelines, provided in a separate rubric, to ensure they maximize their full potential in each meeting. Anticipated, necessary absences should be cleared with the instructor prior to being absent from class. Student athletes should email the instructor prior to any sports-related absences. Missing more than 3 classes, without a valid excuse, will result in repeating the course. Communication is key, not just in class but also in life! If synchronous meeting times do not fit with students schedules, it is recommended that you drop the course.

The University is required to verify academic participation to remain in compliance with federal financial aid regulations. For this reason:

- Students enrolled in an in-seat course must be in attendance at each scheduled meeting after drop/add through the attendance verification period unless the absence has been previously discussed in writing with the instructor.
- Students enrolled in a hybrid course must be in attendance at the in-seat meeting during the attendance verification period <u>and</u> have completed a minimum of one assignment and/or discussion. Unavoidable absence should be discussed in writing in advance with the instructor.
- Students who have not "attended" by the end of the attendance verification period will be dropped from the course roster.
- Students who stop attending a course after the verification period has ended and later seek to withdraw from the course should be aware that Coker is required to verify their last day of attendance or academic participation in the course and use that date as the withdrawal date. This could lead to federal financial aid penalties.
- Students who stop attending a course after the verification period has ended without officially withdrawing from the course and receive a grade of F should be aware that their last date of attendance or academic participation in the course is recorded and this could lead to federal financial aid penalties.

<u>Confidentiality</u>: There will be times where the discussion becomes personal, prompting the sharing of personal stories, experiences, and knowledge. It is expected that **all** discussion remains between student, peers, and instructor, unless a life-threatening issue arises.

Special Accommodations: Reasonable accommodations will be provided for qualified students with documented physical, sensory, learning or psychiatric disabilities that require assistance to fully participate in this class. Late Work: All work is due at the time indicated on the assignment syllabus or discussed in our meetings. I expect that students will complete their work by the assigned due date. If a student is struggling to do so, it is imperative that students communicate with me as soon as possible. Communication is key, not just in class but also in life!

Course Requirements:

Meetings: This class will utilize Google Meets for appointed meetings. This class will operate synchronously and asynchronously. The instructor will hold meetings for students to practice the skills they have learned. These meetings will be held every other week during the course and/or more frequently if the instructor sees fit. Meeting times and dates will be finalized closer to time. Students should choose one meeting time each week to attend from a separate schedule provided. Students will also be provided with a rubric to help them maximize their full potential at each meeting.

Readings: I expect that students will read all assigned materials and will be willing to ask questions about concepts that they do not understand or about which they would like more information. Meetings will not be about me repeating all of what you read --- it will be about expanding upon and deepening your understanding of the information, and practicing the skills that coincide with each theory of therapy. So, the take-home message is: Read and ask questions!

<u>Discussion Posts</u>: There will be weekly discussion posts to help students apply what they learn, and also be able to benefit from the thoughts and feedback of their peers. Posts will be related to the theory/topic covered that week.

<u>Assignments</u>: Students will have weekly assignments to help you go deeper into a particular therapy skill and utilize your critical thinking skills as it relates to the theory/topic covered that week.

Final Project: Students will be assigned a partner to work with for this assignment in which they will choose a particular theory they identify with and show the skills and techniques of counseling they have learned that apply with this particular theory. More details will be provided closer to time.
