PS501 Counseling Theories Credits: 3

COURSE DETAILS

Course Description

This course provides an exploration of counseling theories, including, but not limited to: client-centered, family systems, psychoanalytic, existential, cognitive/behavioral, and multicultural. Students are encouraged to begin developing a personal style and approach to counseling and to deepen their self-awareness of their own motivations, needs, strengths, and limitations as counselors. Issues of cultural diversity, through a counseling framework, will be applied. Students will connect theory and practice by applying counseling techniques through practical applications using role plays and case studies.

Course Learning Objectives

This course will provide students with the opportunity to:

1. Define principal theories of counseling, including, client-centered, humanistic, family systems, psychodynamic, cognitive/behavioral, positive psychology, feminist, relational, and multicultural.
2. Explain multiple counseling theories, highlighting individual theorists and their unique perspectives on understanding struggles and helping clients improve.
3. Compare and contrast different theories, noting key differences from each theory.
4. Apply multiple counseling theories (e.g., via case conceptualization) to fictional clients in conjunction with the students' own attitudes and values.
5. Generate treatment plans to fictional clients using theoretical models to substantiate treatment.
6. Illustrate the significance of multiculturalism in counseling, showing an understanding of the importance of differences in culture, race, class, gender, sexual orientation, religion, and disability in professional helping relationships.

Achievement of learning objectives will be contingent on student effort, ability, and engagement.

Attendance Policy

Students are expected to attend all face-to-face classes and be active online or blended components of their classes.

- On the weeks there are Live Online Class Meetings (either on Blackboard Collaborate or Microsoft Teams) there will be no discussion questions. Professors have the ability to add more Online Class Meetings and discussion questions as they see fit.

Faculty will provide detailed attendance policies in each class syllabus. Please refer to Blackboard once the term begins.

If you believe you are likely to fail, you have the option of withdrawing from this course to avoid a negative impact on your GPA. The last day to withdraw is 10 days prior to the end of the term.

Live Online Class Meetings

Participation in Live Online Class Meetings (either utilizing Blackboard Collaborate or Microsoft Teams) is required in all Fisher College School of Graduate Studies online courses. Participation is defined as attending and interacting in the live environment. Fisher College instructors offer an alternative (recordings) to the students who are unable to attend live, in an effort to keep online education as flexible as possible.

For an 8-week course there will be a minimum of four Online Class Meetings for online courses. To receive credit for a session you must have both a web camera and microphone working during the session. Use of hardware is not optional.

For online courses, students are required, by the end of the first week of the semester, to upload a professionally appropriate image of themselves (i.e. a headshot) to be displayed as

Recorded Online Class Meetings

Virtual classes through Collaborate or Teams are recorded. Massachusetts law requires that parties to a recorded conversation be informed of the recording and consent to the recording. If you do not consent to being recorded, you do not need to participate in the class conversation either verbally or in writing (i.e., chat function or polling feature). You will not be penalized for lack of participation. If you do not consent to being recorded, you must email the instructor in advance.

Library Component

Online databases, periodicals and books available through the library are required to be used to successfully complete this course. APA research reference and citations from these sources, as well as any public library sources are required for all research papers and projects. School of Graduate Studies students in all course work will develop and must display the following information literacy skill set:

1. The ability to create criminal justice related research questions.
2. The ability to use the appropriate research and analysis method that supports a research question.
3. The ability to select the appropriate database from the college library database system based on the data requirements for a research question.
4. The ability to select appropriate books and periodicals from the college and public libraries based on the data requirements for a research question.
5. The ability to evaluate the validity of the data collected based on the scholarly and professional merits of the information reviewed.

Writing and Research Standards

Graduate level writing and research requires extensive documentation and attention to detail. Unless otherwise directed by an instructor the expository writing method will be utilized for all assigned writing and research learning activities. Additionally, all such assignments requiring secondary data sources will be documented using American Psychological Association (APA) citation and reference techniques. The *APA 7th Edition Manual* will be the source reference for American Psychological Association citation and reference techniques, and writing style. However, modification to those headings (but not citations and references) may be required by an instructor or Fisher College. Proper grammar, correct spelling, and punctuation are also areas that will affect the final grade for writing and research assignments. Only professionally or academically credible secondary data sources will be used. **The use of twitter feeds, blogs, editorials, advertising, open source, and position based data sources are not considered**



credible and are prohibited. Lastly, these standards will be included in the rubrics for all writing and research learning activities.
