Course Description

This course introduces the various types and functions of long-term care facilities and related providers. The student will participate in critical analysis of long-term care administration relating to reimbursement, resource use, quality assurance and ethical and legal issues. There will be a comprehensive overview of programs, policies, and services and the ongoing challenges confronting long-term care management.

Assessment Methods

This section of the syllabus contains a listing with brief descriptions of the assessment methods for this course. They are designed to align with the student-learning outcomes and provide you with varied ways to demonstrate mastery of the course content. Additional instructions and related scoring guides or rubrics are posted to Blackboard.





The quality of posts to the graded discussion board will result in 0 to 100 points per week. Each post to the discussion board should contribute to the discussion. Your posts should enhance and continue thread topics; demonstrate what you have absorbed from text readings or website review. Your questions should be relevant to the topics being covered. Posts that simply agree with other post or thread discussion will not receive full credit. Discussion board grading will be based on your ability to demonstrate understanding of the required reading and exploration of weekly assigned website review. You will receive little to no credit for posts that do not add value to the discussion.

You are required to respond to the "parent post" each week no later than Tuesday by 11:59 p.m. unless otherwise noted. In addition to your initial post, you are required to submit two (2) posts to two (2) different fellow students, on two (2) different days by Sunday at 11:59 p.m. each week.

You are required to submit a minimum two references with your posts each week. In order to meet the quality requirements, a post will be at least a paragraph in length (150 - 200 word requirement). You will find that some topics call for lengthier responses.

Discussions close each week on Sunday at 11:59 P.M. EST. Credit for late entries for "make-up" discussion board posts will not be given unless pre-approved by the Instructor.

Online course work (papers, projects and assignments) that are not taken/completed during the allotted time or by posted deadlines will result in a zero for the course work. Those who do not participate in the discussion/assignment for every chapter will receive a zero score for that week which will impact their final average.

State of the Art Justification Memo (20%): Each student is responsible for submitting a detailed justification memo to a "decision maker" on a topic in LTC. Your justification memo needs to be skillfully written, effective and professional so it persuades and convinces the decision maker to take action on your proposal. Include a Cost Benefit Analysis describing the cost effectiveness and long term benefits of your Memo/Proposal. The purpose of this assignment is to assist students in improving thinking skills to defend, analyze, synthesize, problem solve and prepare concise written skills which are critical in the work environment. Your memo must include literature to support your request and identify any cost savings, what and who are involved, and the benefits with your proposal. (Refer to Assignment Details on Blackboard).

Weekly Tests (20%): All essay questions must include detailed, well written and referenced responses.

Creating a Culture of Healthcare Quality using the Institute of Medicine's Six Aims for Improving Care

(20%) Each student is responsible for defining and explaining how each of the Institute Medicine's (IOM) 6 AIMS will play an integral role in reshaping healthcare and in creating a culture of excellence. Each student must provide sufficient research and descriptive examples of each AIM within your essay paper. (Refer to Assignment Details on Blackboard).

Final Research Paper on the National Nursing Home Quality Improvement (NNHQI) Campaign Goals (20%)

Each student is responsible for writing a research paper addressing any one of the nine priority goals identified by the National Nursing Home Quality Improvement (NNHQI) Campaign. Each student is responsible to describe in detail how you would design, implement, monitor, and train staff to successfully achieve this goal in your LTC facility. All providers of healthcare are required and obligated to ensure that the highest quality care and services are delivered safely, timely, and competently to their residents. You must provide sufficient research on your particular area and demonstrate evidence of how you would successfully implement a program plan in your facility. (Refer to Assignment Details on Blackboard).

Discussion Boards (20%): The quality of posts to the graded discussion board will result in 0 to 100 points per week. Each post to the discussion board should contribute to the discussion. Your posts should enhance and continue thread topics; demonstrate what you have absorbed from text readings or website review. Posts that simply agree with other post or thread discussion will not receive full credit. Discussion board grading will be based on your ability to demonstrate understanding of the required reading and exploration of weekly assigned website review. You will receive little to no credit for posts that do not add value to the discussion.
