

**BIL-412:** Romans and Galatians

#### **Course Description**

This class will seek to give a detailed and analytical study of Paul's letters to the Romans and the Galatians.

Credit Hours: 3

Prerequisite Courses: BIL-202, BIL-203

Prerequisite Skills and Knowledge: Familiarity with the Inductive Bible Study (IBS) method found in other courses in this curriculum.

#### **Course Outcomes**

Upon completion of this course, you should be able to:

- 1. Describe the content of Romans and Galatians with reference to the letter's structure and major themes.
- 2. Explain the major themes of Romans and Galatians, including the nature of Christian liberty from sin and the Law, saving faith, the Spirit-led life, and hope.
- 3. Analyze Paul's descriptions of the salvation process, including justification, regeneration,

adoption, entire sanctification, and the life of holiness.

- 4. Appropriate the spiritual truths from Romans and Galatians in one's own life and ministry.
- 5. Design a Bible study lesson based on an Inductive Bible Study of Romans or Galatians.
- 6. Articulate ways in which Romans and Galatians speak to modern or contemporary society.
- 7. Employ the tools of inductive Bible study to interpret various passages from Romans and Galatians.
