**University Mission Statement:**

Lee University is a Christian institution which offers liberal arts and professional education on both the baccalaureate and graduate levels through residential and distance programs. **Catalog Description:**

This course is an exegetical, historical study of the theology of the New Testament with special attention given to Pauline, Johannine, Petrine, and Jewish-Christian formulations of theology.

English Translation of the New Testament (not a paraphrase, preferably New Revised Standard Version)

**Course Goals and Learning Outcomes:****PURPOSE**

The purpose of this course is threefold. First, we will examine three basic methodologies for writing a theology of the New Testament. Secondly, we will read the biblical texts with an eye toward the interpretations that come from scholars who employ these various methods. Finally, from the scholarly interpretations of the individual books and our own study of them, we will construct a theological reading of the New Testament.

**General Learning Objectives (Course Goals):**

*This course seeks to:*

1. Give an understanding of the nature and purpose of New Testament theology.
2. Critically engage the methodologies and biblical exegesis of contemporary scholars.
3. Compare and contrast the various scholarly interpretations of the individual New Testament texts.
4. Ascertain continuity of Christian confession within the New Testament canon.
5. Analyze the historical contexts that gave rise to various articulations of Christian faith during these early years.
6. Help the student comprehend the essence of the New Testament message as reflected in key theological themes (i.e. Soteriology and Eschatology).

**Specific Behavioral Objectives (Learning Outcomes):**

*As a result of the activities and study in this course, the student should be able to:*

1. Define the nature and purpose of New Testament Theology
2. Identify and critically assess the scholarly methodologies used to interpret the New Testament.
3. Demonstrate an understanding of the historical contexts and theological themes that gave rise to various articulations of Christian faith.
4. Develop an interpretive grid by which to understand and explain the meaning and significance of New Testament texts.
5. Analyze discontinuities and/or tensions between the theological articulations engendered by the various writers of the New Testament texts.
6. Demonstrate the ability to read critically and identify key theological concepts located within the New Testament.

**Course Assessments:**

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of “a” and “b” above) and then response posts interacting to other students’ initial posts (evaluation of “c” above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor. .
- C. **Unit Assignments.** There are two (2) unit reflection papers assigned during the course. Each paper should be no less than 2 pages and submitted in the writing style based on the requirements of your chosen major (APA or Turabian). The first paper is due at the end of Unit 4 and the second is due at the end of Unit 7. These will be direct reflections on the key New Testament passages under discussion. Further directions and information will be provided with the assignment.

D. **Course Project.** There is one (1) research paper assigned in this course. The paper must be no less than 7 pages and submitted in the writing style based on the requirements of your chosen major (APA or Turabian). Further directions and information will be provided with the assignment.

**Letter Grade Equivalencies:**

**A** = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.

**B** = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.

**D** = Quality and quantity of work is below average. Has marginal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at below acceptable levels.

**F** = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.

#### **Unit and Time Distribution:**

The time to complete each unit is approximately 17 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

## **POLICIES**

#### **Attendance Policy:**

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

#### Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion)
- No late assignments will be accepted after the close of the final Unit.

## EXPECTATIONS

#### Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
