Course Goals and Learning Outcomes:**PURPOSE**

The purpose of this course is to acquaint the student with the intentions of Paul in writing the Epistles to the Romans and Galatians, cultural setting, their message, contemporary missionary implications, and relevance to men and women of the 21st century.

General Learning Objectives (Course Goals):

This course seeks to:

1. Familiarize the student with Paul's general purpose for writing the letters to the Romans and Galatians.
2. Expand the student's knowledge of the salient theological themes addressed by Paul in Romans and Galatians.
3. Acquaint the student with important Greek terms and grammar in the books of Romans and Galatians.
4. Develop the student's research and writing skills by completing an exegetical writing assignment.

5. Provide opportunities for students to critically engage the letters to the Romans and Galatians, and the textbooks.
6. Encourage students to experience spiritual benefits to the study of these letters.

Specific Behavioral Objectives (*Learning Outcomes*):

As a result of the activities and study in this course, the student should be able to:

1. Demonstrate knowledge of Paul's background, writings, and relationship to the Roman church and the churches of Galatians.
2. Describe the origins of the churches of Galatia.
3. Compare and contrast the main theories about precisely who the identity of the Galatians.
4. Explain the occasion for Paul's letter to the Galatians.
5. Show an understanding of the general theological themes contained in Galatians.
6. Identify the possible origins of the Roman church.
7. Explain the occasion for Paul's letter to the Roman church.
8. Identify and show an understanding of the major theological themes contained in Romans.
9. Discuss the historical influence of Romans on key periods of the Christian church.
10. Show an understanding of key Greek terms and grammar in the books of Romans and Galatians.

Major Topics:

- A. The Apostle Paul
- B. General overview of Galatians
- C. General overview of Romans
- D. Salvation by Faith
- E. Similarities and differences in Romans and Galatians

Course Assessments:

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of "a" and "b" above) and then response posts interacting to other students' initial posts (evaluation of "c" above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor.
- C. **Unit Assignments (Reflections).** The student will be required to turn in 3 reflections on the course readings which are due in the even numbered units. Further instructions are provided in the course.
- D. **Course Project (Research).** The student is required to submit a research paper consisting of a minimum of eight full pages on a passage in Romans or Galatians. The paper must be properly documented and in the writing style based on the requirements of your chosen major (APA or Turabian). Use the recommended readings below as an example for the types of resources that you should use in your papers. Further guidelines and instructions concerning the content and format of the paper will be provided in the course.

Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.</p>		
<p>B = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.</p>		
<p>C = Quality and quantity of work is average. Has average comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.</p>

Unit and Time Distribution:

The time to complete each unit is approximately 14-17 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

POLICIES**Attendance Policy:**

- b. paraphrasing all or part of another person's words without documentation.
- c. stating an idea, theory, or formula as your own when it actually originated with another person.
- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion)
- No late assignments will be accepted after the close of the final Unit.

EXPECTATIONS**Faculty Expectations of Students:**

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
- Review the course syllabus and other preliminary course materials thoroughly as early as possible during the first few days of the course.
