**University Mission Statement:**

**Course Goals and Learning Outcomes:****PURPOSE**

A course designed to introduce the student to the field of Christian Education; an examination of the biblical basis and theological foundations of the local church and parachurch agencies of Christian Education.

**General Learning Objectives (Course Goals):**

*This course seeks to:*

1. Provide theological perspectives on Christian formation.
2. Explore contemporary issues surrounding the relevance of Christian Education today.
3. Examine the work of the Holy Spirit in the educational process.
4. Develop the Church's strategies for discipleship and ministerial education.
5. Study generational perspectives for ministering to the Builders, Boomers, Busters, and Bridgers.
6. Review the Church's allies for Christian Education: Home, Church, and Parachurch Educational Organizations.

**Specific Behavioral Objectives (Learning Outcomes):**

*As a result of the activities and study in this course, the student should be able to:*

1. Demonstrate knowledge of the biblical basis for Christian Education.
2. Critically examine educational issues and concerns based on biblical theology rather than culturally defined norms.
3. Critique the success of Christian Education from a biblical/theological perspective.
4. Understand how to use the necessary critical/reflective processes in the development of a proper theological understanding of Christian formation.
5. Evaluate the importance of biblical discipleship in the development of Christian education as applied to children, youth, and adults.
6. Understand and apply the teaching/learning process in various settings, contexts, and agencies.
7. Identify and personally develop an effective teaching/learning style based on integrative teaching strategies and dynamic lesson plans.

**Major Topics:**

- A. Express the historical foundations of Christian education and its importance as a vital part of the Church's ministry.
- B. Articulate the teaching methods of Jesus Christ and summarize Christ's methodology to make disciples.
- C. Critique contemporary Christian education using appropriate biblical exposition and theological method.
- D. Understand the fundamental principles of a Pentecostal-Wesleyan theology regarding the work of the Holy Spirit in education.
- E. Identify and apply teaching styles that act as a catalyst for guiding learners toward higher levels of knowledge.
- F. Effectively communicate to all age groups by identifying their unique characteristics and developmental patterns.
- G. Design successful curriculum using proper structure and methods to meet learners' needs.
- H. Define and outline the systematic process of spiritual formation.
- I. Summarize the various definitions of Christian education and apply its aims and purposes into one's own life and ministry.

**Course Assessments:**

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of "a" and "b" above) and then response posts interacting to other students' initial posts (evaluation of "c" above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor. There are 16 threaded discussions throughout this course.

- C. **Unit Assignments:** Accountability for all reading assignments includes quizzes and writing assignment [“The Role of Jesus’ Teaching and the Holy Spirit in Education” in 3-5 typed pages in the writing style based on the requirements of your chosen major (APA or Turabian)].
- D. Exam: There are 4 quizzes and a Mid-Term exam in this course.
- E. Course Project: The course project will be considered the final for this course. The student will do an *Organization, Administration, and Lesson Planning for One Specialized Ministry*. More details will be provided in the course.

#### Letter Grade Equivalencies:

**A** = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.

**B** = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a graduate cohort member. Work shows intuition and creativity. Example "B"

work indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.

**C** = Quality and quantity of work in and out of class is average. Has marginal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.

**D** = Quality and quantity of work is below average. Has minimal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at below acceptable levels.

**F** = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.

#### Unit and Time Distribution:

The time to complete each unit is approximately 14-16 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

## POLICIES

#### Attendance Policy:

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

Online courses will have weekly mechanisms for student participation, which can be documented by submission/completion of assignments, participation in threaded discussions, and/or specific communication with the instructor as outlined within the syllabus.

#### Academic Honesty Policy/Information:

Cheating is defined as the use or attempted use of unauthorized materials or receiving unauthorized assistance or communication during any academic exercise.

Examples of cheating include:

- Submitting work for academic evaluation that is not the your own.
- Receiving assistance from another person during an examination.
- Using prepared notes or materials during an examination.
- Permitting another student to copy your work.
- Plagiarism.
- Falsification.
- Other misrepresentations of academic achievement submitted for evaluation or a grade.

As stated in the LEE UNIVERSITY Catalog, plagiarism is presenting as your own work the words, ideas, opinions, theories, or thoughts which are not common knowledge. Students who present others' words or ideas as their own without fair attribution (documentation) are guilty of plagiarizing. Unfair attribution includes, but is not limited to, a direct quotation of all or part of another's words without appropriately identifying the source. It is also unfair attribution to have included a source within a Works Cited page without having carefully cited the source within the text of the document.

Plagiarism also includes, but is not limited to, the following acts when performed without fair attribution:

- a. Directly quoting all or part of another person's words without quotation marks, as appropriate to the discipline.
- b. Paraphrasing all or part of another person's words without documentation.
- c. Stating an idea, theory, or formula as your own when it actually originated with another person.
- d. Purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

#### Late Policy:

- No credit is available for postings of any kind made in the **Discussion Forums** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion)
- No late assignments will be accepted after the close of the final Unit.

## EXPECTATIONS

#### Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
- Review the course syllabus and other preliminary course materials thoroughly as early as possible during the first few days of the course.
- Be responsible for raising any questions or seeking clarification about these materials, if necessary, within the first week of the session.
- Frequently check the course calendar for due dates.
- Submit assignments and papers on time, and take tests by the posted dates. Acceptance of late work and any penalties for late submissions are up to the discretion of the instructor, based on the expectations outlined in the course syllabus.
- Contribute meaningful, timely comments to online discussions according to guidelines provided.
- Contribute substantively to group assignments (if required in course).
- Check for University announcements each time you log onto the LMS. These postings are critical.

- Complete the "Student Survey of Instruction" for each course to evaluate the instructor and the course.
