**University Mission Statement:**

**Course Goals and Learning Outcomes:****PURPOSE**

This course is intended to provide students with an introduction to Christian spirituality and its role in ministry. Specifically, the course is intended to provide students with an understanding of the biblical, theological, and psychosocial foundations of both historical and contemporary models and practices of Christian spirituality. Further, the course is intended to help the student better understand her/his own spirituality and the spirituality of those to whom he/she will minister.

**General Learning Objectives (Course Goals):**

*This course seeks to:*

1. Examine the biblical, theological and psychosocial foundations of historic and contemporary models of Christian spirituality.
2. Explore the biblical and theological foundations of traditional and contemporary practices of Christian spiritual formation.
3. Consider the impact of culture and context in understanding and developing Christian spirituality.
4. Investigate available resources for both personal and corporate spiritual development.

**Specific Behavioral Objectives (Learning Outcomes):**

*As a result of the activities and study in this course, the student should be able to:*

1. Articulate a biblical foundation of Christian spirituality.
2. Relate central themes of theology (e.g. humanity as *imago dei*, the fall and redemption of humankind, sanctification, etc.) to Christian spirituality.
3. Identify the underlying biblical, theological and psychosocial assumptions of historic and contemporary models of Christian spiritual formation.
4. Determine how Christian practices (e.g. spiritual disciplines, worship, sacramental observances, etc.) impact spiritual formation.
5. Analyze the effect of 21<sup>st</sup> century worldviews on Christian spirituality.
6. Evaluate resources for personal and corporate spiritual development.
7. Develop a contextual plan of spiritual development.

- A. Biblical foundations of Christian spirituality
- B. Theological foundations of Christian spirituality
- C. Psychosocial foundations of Christian spiritual development
- D. Spiritual disciplines
- E. Christian sacraments (Protestant tradition)
- F. Models of Christian spiritual development
- G. Resources for personal and corporate spiritual development

**Course Assessments:**

- A. **Participation.** You are required to participate in this course on a weekly basis. Although there is no participation grade, your participation is assessed as you engage in discussions and complete the written assessment activities. The course is designed so that each unit has a corresponding written lecture. The lectures provide explanatory content in addition to the textbook and article assignments; it is essential that you read the lecture, as well as any associated media presentations. A key aspect of your participation is the timely completion of all assigned readings, corresponding written activities, papers, threaded discussions, etc. The assignments must be completed within the timeframe specified in the assignment instructions. All times should be understood as Eastern Time.
- B. **Turabian Format.** The School of Religion requires Turabian formatting as the style for all written assignments. Please see the *School of Religion Manual of Style for Papers* (on LMS) for a current guide to Turabian format.
- C. **Gender Inclusive Language.** The School of Religion supports and expects the use of gender inclusive language in written and oral communication. Examples of gender inclusive language

include: humankind rather than mankind; people rather than men or women, etc. Obviously, if gender specificity is appropriate, as in referring to a mother as “she,” that is acceptable.

- D. **Threaded Discussions.** The threaded discussions are an opportunity for you to demonstrate your knowledge of the material and to interact with other students. They will facilitate the accomplishment of learning outcomes 1-6. Discussions will be evaluated as follows: 1) on the demonstration of understanding the discussion topic; 2) on the level of engagement with the discussion topic; 3) on the purposeful interaction with other students. An initial/original post is required, and then a minimum of two posts in response to other students’ initial posts.
- E. **Unit Assignments.** Each unit has a Unit Assignment based on readings from the *The Brazos Introduction to Christian Spirituality* textbook and will facilitate the accomplishment of learning outcomes 1, 2, and 3.
- F. **Course Project.** The *In Search of a Confident Faith* textbook will be read beginning with Unit 3 and must be completed during Unit 4. Reading this textbook will facilitate the accomplishment of learning outcomes 4, 5, and 6.
- G. **Course Project.** The *Renovation of the Heart* textbook will be read beginning with Unit 5 and must be completed during Unit 6. Reading this textbook will facilitate the accomplishment of learning outcomes 1, 2, 3, and 4. Additionally, various articles will be found in the course. The associated requirements for these articles will be described within the individual course units. The articles and associated activities will facilitate the accomplishment of learning outcomes 1-6.
- H. **Course Project:** This **Plan of Contextual Spiritual Development** assignment serves as a culminating project for this course. You will develop a contextually appropriate plan for spiritual development. The plan will be based on the article “Growing Christlike Together” by Jeff Nikkel. The article is available in the course and will serve as the guide for your spiritual development plan. Your plan should be for a specific ministry context (e.g. youth ministry in the southeastern United States), and must address the ten key growth areas Nikkel targets in the article. Detailed instructions for the assignment are available in the course.

<p><b>A</b> = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.</p>		
<p><b>B</b> = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.</p>		
<p><b>C</b> = Quality and quantity of work in and out of class is average. Has average comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.</p>		
<p><b>F</b> = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.</p>		
<b>Unit and Time Distribution:</b>		
<p>The time to complete each unit is approximately 14-16 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.</p>		

## POLICIES

### Attendance Policy:

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

Online courses will have weekly mechanisms for student participation, which can be documented by submission/completion of assignments, participation in threaded discussions, and/or specific communication with the instructor as outlined within the syllabus.

### Academic Honesty Policy/Information:

Cheating is defined as the use or attempted use of unauthorized materials or receiving unauthorized assistance or communication during any academic exercise.

Examples of cheating include:

- Submitting work for academic evaluation that is not the your own.
- Receiving assistance from another person during an examination.

- Using prepared notes or materials during an examination.
- Permitting another student to copy your work.
- Plagiarism.
- Falsification.
- Other misrepresentations of academic achievement submitted for evaluation or a grade.

As stated in the LEE UNIVERSITY Catalog, plagiarism is presenting as your own work the words, ideas, opinions, theories, or thoughts which are not common knowledge. Students who present others' words or ideas as their own without fair attribution (documentation) are guilty of plagiarizing. Unfair attribution includes, but is not limited to, a direct quotation of all or part of another's words without appropriately identifying the source. It is also unfair attribution to have included a source within a Works Cited page without having carefully cited the source within the text of the document.

Plagiarism also includes, but is not limited to, the following acts when performed without fair attribution:

- a. directly quoting all or part of another person's words without quotation marks, as appropriate to the discipline.
- b. paraphrasing all or part of another person's words without documentation.
- c. stating an idea, theory, or formula as your own when it actually originated with another person.
- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

#### Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion)
- No late assignments will be accepted after the close of the final Unit.

## EXPECTATIONS

#### Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
- Review the course syllabus and other preliminary course materials thoroughly as early as possible during the first few days of the course.

- Be responsible for raising any questions or seeking clarification about these materials, if necessary, within the first week of the session.
- Frequently check the course calendar for due dates.
- Submit assignments and papers on time, and take tests by the posted dates. Acceptance of late work and any penalties for late submissions are up to the discretion of the instructor, based on the expectations outlined in the course syllabus.
- Contribute meaningful, timely comments to online discussions according to guidelines provided.
- Contribute substantively to group assignments (if required in course).
- Check for University announcements each time you log onto the LMS. These postings are critical.
- Use Lee email address.
- Complete the "Student Survey of Instruction" for each course to evaluate the instructor and the course.

#### Students' Expectations of Faculty:

- The opportunity to be active participants in a stimulating and challenging education that is global in scope, interactive in process and diverse in content and approach.
- A friendly, respectful, open, and encouraging learning environment.
- A course outline or syllabus that clearly provides information regarding course content, teaching methods, course objectives, grading, attendance/participation policies, due dates, and student assessment guidelines.

- To have access to instructor feedback and grading on projects, exams, papers, quizzes, etc., within ten (10) days of assignment due date so students are able to determine where they have made errors or need additional work.
