Course Goals and Learning Outcomes:**PURPOSE**

This course is intended to provide students an opportunity to develop a theologically and culturally sound philosophy of music for worship, based on an understanding of the practices and philosophies of scripture, history and current practices.

General Learning Objectives (Course Goals):

This course seeks to:

1. Provide an overview of the operating philosophies behind the church music practices of each major period from Biblical times to the present.
2. Provide the student an opportunity to develop a philosophy of church music that is scripturally and historically sound, while remaining flexible and creative in response to the ever-changing contemporary scene.
3. Develop in the student an appreciation for the role of various historical and contemporary music styles in the worship of the Church.
4. Provide the student with philosophical and theological bases for the appropriate use of music in the worship service.

5. Acquaint the student with current issues, trends and philosophies of music and worship.
6. Acquaint the student with various philosophies of leading music in worship.

Specific Behavioral Objectives (Learning Outcomes):

As a result of the activities and study in this course, the student should be able to:

1. Discuss the operating philosophies of music and worship in major periods of church history.
2. Determine the appropriateness of various types of music used in worship from an historical, scriptural and cultural basis.
3. Express his/her personal philosophy of music and worship in anticipation of applying this philosophy to a local music ministry.
4. Discuss the traditions and practices of music in the Pentecostal and charismatic church.
5. Observe and evaluate what is happening in current music and worship practices.
6. Express in writing and discussion his/her philosophy of leading music in worship

Major Topics:

- A. Scriptural principles of music and worship
- B. Music and worship in church history
- C. Authentic worship
- D. The role of music in worship
- E. Pentecostal and charismatic/Evangelical philosophies of Music and worship
- F. Current issues and trends in music and worship
- G. Philosophies of leading music in worship
- H. Blended worship/Convergence Worship

Course Assessments:

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Initial posts should be 100-250 words based on themes/subjects provided. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of "a" and "b" above) and then response posts interacting to other students' initial posts (evaluation of "c" above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor.
- C. **Unit Assignments (Base).** Each student is to discuss what they currently know about worship and music during provided historical periods. This assignment is intended to help the instructor understand the base knowledge of the student in the content area before taking this course.
- D. **Unit Assignments (Observation).** Each student will complete a series of worship service observations (Units 3-6) using provided links so the same services are observed by all students. Observation points will be provided for each assignment so the student can provide a written observation which will reflect on the assignment unit and units prior.
- E. **Course Project.** Each student will select a topic, approved by the professor, concerning the course content, and complete a formal 10-page research paper. The intent of this project is to demonstrate college research skills and writing, a deeper knowledge of a specific area of

content covered in the reading and discussion, and reflect seven weeks of reading, research, thoughtful writing, and a strong base of knowledge in a specific area using the Turabian (SOR Manual of Style) format.

Letter Grade Equivalencies:

A = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.

B = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.

C = Quality and quantity of work is average. Has average comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.

D = Quality and quantity of work is below average. Has marginal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at below acceptable levels.

F = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.

Unit and Time Distribution:

The time to complete each unit is approximately 14-17 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

POLICIES

Attendance Policy:

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

Online courses will have weekly mechanisms for student participation, which can be documented by submission/completion of assignments, participation in threaded discussions, and/or specific communication with the instructor as outlined within the syllabus.

Academic Honesty Policy/Information:

Cheating is defined as the use or attempted use of unauthorized materials or receiving unauthorized assistance or communication during any academic exercise.

Examples of cheating include:

- Submitting work for academic evaluation that is not the your own.
- Receiving assistance from another person during an examination.
- Using prepared notes or materials during an examination.
- Permitting another student to copy your work.
- Plagiarism.
- Falsification.
- Other misrepresentations of academic achievement submitted for evaluation or a grade.

As stated in the LEE UNIVERSITY Catalog, plagiarism is presenting as your own work the words, ideas, opinions, theories, or thoughts which are not common knowledge. Students who present others' words or ideas as their own without fair attribution (documentation) are guilty of plagiarizing. Unfair attribution includes, but is not limited to, a direct quotation of all or part of another's words without appropriately identifying the source. It is also unfair attribution to have included a source within a Works Cited page without having carefully cited the source within the text of the document.

Plagiarism also includes, but is not limited to, the following acts when performed without fair attribution:

- a. directly quoting all or part of another person's words without quotation marks, as appropriate to the discipline.
- b. paraphrasing all or part of another person's words without documentation.

- c. stating an idea, theory, or formula as your own when it actually originated with another person.
- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion)
- No late assignments will be accepted after the close of the final Unit.

EXPECTATIONS**Faculty Expectations of Students:**

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
- Review the course syllabus and other preliminary course materials thoroughly as early as possible during the first few days of the course.
- Be responsible for raising any questions or seeking clarification about these materials, if necessary, within the first week of the session.
- Frequently check the course calendar for due dates.
- Submit assignments and papers on time, and take tests by the posted dates. Acceptance of late work and any penalties for late submissions are up to the discretion of the instructor, based on the expectations outlined in the course syllabus.
- Contribute meaningful, timely comments to online discussions according to guidelines provided.
- Contribute substantively to group assignments (if required in course).
- Check for University announcements each time you log onto the LMS. These postings are critical.
