**Course Goals and Learning Outcomes:****PURPOSE**

This course is designed to 1) introduce students to varied methods and theories of assistance in grief recovery; 2) utilize current research findings; 3) allow the student to explore myths of grief; 4) identify short-term energy relievers that hinder grief recovery; 5) explore communication of grief in a concise step-by-step process; and 6) teach basic principles and active steps toward grief recovery.

**General Learning Objectives (Course Goals):**

*This course seeks to:*

1. Critically evaluate current theories and methods of grief and bereavement.
2. Review definitions and processes of grief and recovery.
3. Explore and offer guidelines in tragic circumstances of suicide, murder, birth of an infant with disability, death of an infant, AIDS and other specific losses which are perceived unnatural.
4. Enable students to fully understand the grief process functions.
5. Promote understanding of intellectual and emotional process of grief recovery.
6. Encourage students to help others learn to grieve in a healthful way.

**Specific Behavioral Objectives (Learning Outcomes):**

*As a result of the activities and study in this course, the student should be able to:*

1. Identify psychological theories of grief and bereavement.

2. Recognize validity and reliability of current research findings.
3. Be aware of a healthy grief process.
4. Demonstrate recovery as an active choice.
5. Help students recognize stages and common responses.
6. Decipher short term energy relief behaviors.
7. Investigate myths on various ways to deal with grief.
8. Implement assignments in preparation of active grief.
9. Identify incomplete grief.
10. Evaluate and apply various recovery components.
11. Discuss the difference of completion from forgetting.
1. Apply knowledge of appropriate response to assist grievers.

**Course Assessments:**

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of “a” and “b” above) and then response posts interacting to other students’ initial posts (evaluation of “c” above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. ## POLICIES

### Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be

accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion.)

- No late assignments will be accepted after the close of the final unit.

## EXPECTATIONS

### Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
