**University Mission Statement:**

Lee University is a Christian institution which offers liberal arts and professional education on both the baccalaureate and graduate levels through residential and distance programs. **Catalog Description:**

A study of the doctrine of the Holy Spirit with emphasis upon the Spirit's relationship to Christ. The work of the Holy Spirit in relation to other fundamental doctrines will also be considered (e.g. creation, salvation, ecclesiology, eschatology, etc.). Special attention will be focused on the work of the Holy Spirit as teacher, helper, discipler, and on the experience of Spirit baptism with the initial evidence of glossolalia. Some attention will be given to the meaning of "living in the Spirit" and spiritual gifts.

**Course Goals and Learning Outcomes:****PURPOSE**

This course is designed to explore the doctrine of the Holy Spirit from both a biblical and historical theological perspective, and to survey the work of the Holy Spirit with regard to other fundamental doctrines. Attention will be given to practical aspects of pneumatology, such as "living in the Spirit" and spiritual gifts.

**General Learning Objectives (Course Goals):**

*This course seeks to:*

1. Provide a brief historical overview of the rise and growth of the Pentecostal movement.
2. Share the extended ministry of the Holy Spirit as recorded in both the Old and New Testaments.
3. Distinguish between the views of the Holy Spirit that various groups propose.
4. Provide a biblical balanced view of the person, ministries and manifestations of the Spirit.

**Specific Behavioral Objectives** (*Learning Outcomes*):

*As a result of the activities and study in this course, the student should be able to:*

1. Outline a historical overview of the origins of the Pentecostal doctrine of the Holy Spirit.
2. Distinguish the ministry of the Holy Spirit in each of the testaments and in our contemporary world.
3. Articulate what is meant by baptism of the Holy Spirit and explain how the Pentecostal perspective differs from that of other Christian traditions as well as the various Charismatic perspectives.
4. Explain biblically the guidelines for the operation of the gifts of the Spirit in the corporate body.
5. Understand who the Spirit is in the triune Godhead.

**Course Assessments:**

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of "a" and "b" above) and then response posts interacting to other students' initial posts (evaluation of "c" above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor.
- C. **Unit Assignments:** There are two (2) reflection papers assigned in this course. Each paper must be no less than seven (7) and no more than ten (10) typed pages and is to be submitted in Turabian (SOR Manual of Style) format. Reflection papers are graded according to the

*Reflection Paper Rubric* (accessible in the course resources). Approved articles for the Reflection Papers are indicated with an asterisk in the Supplemental Bibliography [see KNOWLEDGE BASE/WORKING BIBLIOGRAPHY (READING LIST) below]. The first paper is due in Unit 4 and the second in Unit 6. It is suggested you begin your work on them early (possibly a unit or two before) to ensure you have the time needed to complete them. Directions for the papers and an evaluation rubric are provided in the Course Resources folder.

- D. **Exams.** There are three (3) exams given during this course. Material from the required readings and electronic lectures are the source for the exams. All exams must be taken by the assigned deadline.

#### Letter Grade Equivalencies:

**A** = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.

**B** = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work

indicates good quality of performance and is given in recognition for solid work; a "B" should be considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.

**C** = Quality and quantity of work in and out of class is average. Has average comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.

**D** = Quality and quantity of work is below average. Has marginal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at below acceptable levels.

**F** = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.

#### **Unit and Time Distribution:**

The time to complete each unit is approximately 17 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

## **POLICIES**

#### **Attendance Policy:**

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

Online courses will have weekly mechanisms for student participation, which can be documented by submission/completion of assignments, participation in threaded discussions, and/or specific communication with the instructor as outlined within the syllabus.

Examples of cheating include:

- Falsification.

- b. paraphrasing all or part of another person's words without documentation.
- c. stating an idea, theory, or formula as your own when it actually originated with another person.
- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

#### Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion.)
- No late assignments will be accepted after the close of the final Unit.

## EXPECTATIONS

#### Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
