Catalog Description:

This course is an introduction to the most recent theological expressions of the first, second and third “waves” of pentecostalism. Topics to be covered include Roman Catholic perspectives on baptism in the Holy Spirit, spiritual gifts among evangelicals, indigenous pentecostal traditions outside the United States, the rise of academic theology in pentecostal denominations, theological method, pentecostals and ecumenism, as well as the doctrines of Jesus Christ, the Holy Spirit, the church, salvation, and the kingdom of God.

Course Goals and Learning Outcomes:**PURPOSE**

This course is intended to introduce developments in pentecostal theology from the 1960s to the present, with a particular focus on major figures and trends that have implications for theology.

General Learning Objectives (Course Goals):

This course seeks to:

1. Provide an overview of significant theologians and trends in recent pentecostal theology.
2. Describe similarities and differences of theology among various kinds of pentecostals throughout the world.
3. Examine pentecostal perspectives of classical theological questions and concerns.

4. Demonstrate that pentecostal theology is a global phenomenon that faces challenges and has significant potential in the 21st century.

Specific Behavioral Objectives (*Learning Outcomes*):

As a result of the activities and study in this course, the student should be able to:

1. Explain the philosophical and theological causes that contribute to each major figure and trend.
2. Analyze and identify the methodologies of major pentecostal theologians from the 1960s to the present.
3. Determine the connections between various theological themes as found in each of the three “waves” of pentecostalism.
1. Synthesize and assess the prospects of pentecostal theology for the theological questions surrounding Jesus Christ, the Holy Spirit, the church, salvation, ecumenism, and interreligious dialogue.

Major Topics:

- A. Basics of early, first-wave pentecostal theology
- B. Catholic Charismatic Renewal
- C. Baptism in the Holy Spirit, Christian initiation, sacraments, and grace
- D. Evangelism and church growth
- E. Indigenous churches and global pentecostal theology: Africa, Asia, Europe, and South America
- F. Various types of theological method among pentecostals
- G. Oneness pentecostalism
- H. Pentecostals, ecumenical dialogue, interreligious dialogue
- I. “Third article” theology and the task of theology in the 21st century

Course Assessments:

- A. **Text/Media.** All text/media is evaluated in the threaded discussions and assignments.
- B. **Threaded Discussions.** The threaded discussions are an opportunity for students to demonstrate their knowledge of the course material and interact with fellow students. Just doing an initial post and/or response will not guarantee any point value. Discussions will be evaluated as follows: a) on the depth of engagement with the discussion topic and/or issue; b) on the depth of understanding of the topic and/or issue; and c) on the depth of interaction with the other students. An initial post is required (evaluation of “a” and “b” above) and then response posts interacting to other students’ initial posts (evaluation of “c” above). Once the discussion deadline is reached, there will be no further opportunity to attain points for that discussion. If you have further questions on how these are evaluated, please contact your instructor.
- C. **Exams.** There will be two (2) sectional exams. Each will cover material from the lesson introductions, reading assignments, and any other materials that the instructor may indicate. Test 1 will cover Units 1-4. Test 2 will cover Units 5-7.
- D. **Course Projects.** Each student will write two research papers. Each paper will be 10 pages long, in addition to the cover page and bibliography. Each paper will draw on a minimum of 7 academic sources in addition to the textbook. The first paper will be a critical review of one book from the textbook bibliography by one of the following figures: Simon K. H. Chan, Frank D. Macchia, or Amos Yong. In addition to the book being reviewed, the student will use no fewer than 7 reviews of that book published in peer-reviewed journals. The paper will both

evaluate the content of the book in question and assess the accuracy of the criticisms of the published reviews. The first paper is due by the end of Unit 4. The second paper will address one of the following issues covered in the course: Charismatic Renewal in the Roman Catholic Church, Prosperity Theology/Preaching, Baptism in the Holy Spirit and Sacraments, or Pentecostalism and Ecumenism. Articles in *The New International Dictionary of Pentecostal and Charismatic Movements*, rev. ed., ed. Stanley M. Burgess (Grand Rapids: Zondervan, 2002) may be useful for attaining initial orientation to the major themes and relevant literature related to these topics. The second paper is due by the end of Unit 7.

Letter Grade Equivalencies:

A = Clearly stands out as excellent performance. Has unusually sharp insights into material and initiates thoughtful questions. Sees many sides of an issue. Articulates well and writes logically and clearly. Integrates ideas previously learned from this and other disciplines. Anticipates next steps in progression of ideas. Example "A" work should be of such nature that it could be put on reserve for all cohort members to review and emulate. The "A" cohort member is, in fact, an example for others to follow.

B = Demonstrates a solid comprehension of the subject matter and always accomplishes all course requirements. Serves as an active participant and listener. Communicates orally and in writing at an acceptable level for a cohort member. Work shows intuition and creativity. Example "B" work indicates good quality of performance and is given in recognition for solid work; a "B" should be

considered a good grade and awarded to those who submit assignments of quality less than the exemplary work described above.

C = Quality and quantity of work in and out of class is average. Has average comprehension, communication skills, or initiative. Requirements of the assignments are addressed at least minimally.

D = Quality and quantity of work is below average. Has marginal comprehension, communication skills, or initiative. Requirements of the assignments are addressed at below acceptable levels.

F = Quality and quantity of work is unacceptable and does not qualify the student to progress to a more advanced level of work.

Unit and Time Distribution:

The time to complete each unit is approximately 14-16 hours per week on average for a three hour course. Actual assignment completion times will vary. A more detailed breakdown of each assignment can be found within the course.

POLICIES

Attendance Policy:

At Lee University student success is directly related to the student actively attending and engaging in the course. Online courses are no different from classroom courses in this regard; however, participation must be defined in a different manner.

Online courses will have weekly mechanisms for student participation, which can be documented by submission/completion of assignments, participation in threaded discussions, and/or specific communication with the instructor as outlined within the syllabus.

Academic Honesty Policy/Information:

Cheating is defined as the use or attempted use of unauthorized materials or receiving unauthorized assistance or communication during any academic exercise.

Examples of cheating include:

- Submitting work for academic evaluation that is not the your own.
- Receiving assistance from another person during an examination.
- Using prepared notes or materials during an examination.
- Permitting another student to copy your work.
- Plagiarism.
- Falsification.
- Other misrepresentations of academic achievement submitted for evaluation or a grade.

Students who present others' words or ideas as their own without fair attribution (documentation) are guilty of plagiarizing. Unfair attribution includes, but is not limited to, a direct quotation of all or part of another's words without appropriately identifying the source. It is also unfair attribution to have included a source within a Works Cited page without having carefully cited the source within the text of the document.

Plagiarism also includes, but is not limited to, the following acts when performed without fair attribution:

- a. directly quoting all or part of another person's words without quotation marks, as appropriate to the discipline.
- b. paraphrasing all or part of another person's words without documentation.
- c. stating an idea, theory, or formula as your own when it actually originated with another person.
- d. purchasing (or receiving in any other manner) a term paper or other assignment, which is the work of another person, and submitting that work as if it were one's own.

Late Policy:

- No credit is available for postings of any kind made in the **Threaded Discussions** after a given Unit ends.
- If your faculty approves your submission of late assignments, each assignment score will be penalized 10% per day up to five days late. After the fifth day, late assignments will not be accepted. (Note: An assignment is a paper, a project, a team presentation, etc., **not** a discussion.)
- No late assignments will be accepted after the close of the final Unit.

EXPECTATIONS

Faculty Expectations of Students:

- Have consistent access to a computer and possess baseline computer and information skills prior to taking online courses.
- Log into their courses within 24 hours of the beginning of the session to confirm their participation. (Students who register after the session has begun will be responsible for any assignments or material already covered.)
- Take an active role in each unit, participating fully in discussions, assignments and other activities throughout the entire session. If some event interferes with that participation, the student is responsible for notifying the instructor in advance.
- Review the course syllabus and other preliminary course materials thoroughly as early as possible during the first few days of the course.
- Be responsible for raising any questions or seeking clarification about these materials, if necessary, within the first week of the session.
- Frequently check the course calendar for due dates.
- Submit assignments and papers on time, and take tests by the posted dates. Acceptance of late work and any penalties for late submissions are up to the discretion of the instructor, based on the expectations outlined in the course syllabus.
