Course Learning Outcomes. Each student will:

- 1) Identify stakeholders and discuss strategic management of relationships
- 2) Summarize corporate governance and legal, regulatory, and political issues.
- 3) Explain employee and consumer relations
- 4) Explain technology and sustainability issues.
- 5) Discuss social responsibility in a global environment.

Means of Assessment. The final exam will be used as the assessment for this course.

Experiential Exercise. *One Experiential Exercise* project (located at the end of each chapter of the text for each week's studies) will be assigned weekly and students shall write a 600-750 word report (in MS Word) in response to the issues presented in the exercise.

<u>Case Analysis</u>. One case is assigned in week 7 that requires extensive study of the case and familiarity with the contents of the text. Students are to review the case and respond to the "Questions for Discussion" found at the end of the case. Students will prepare a thorough detailed discussion that shall be between 400-500 words. APA formatting, style, and font shall be used in this and all writings for this course.

Forums. The Discussion Forums are not informal chat rooms. They are used to further the sharing of knowledge. Students must follow these guidelines below when participating in the forums:

<u>Week 1 Attendance Forum</u>: ALL students are required to post in the Week 1 Attendance Forum by Tuesday evening of the first week. If you fail to do so, you will be automatically withdrawn from the course.

<u>Forum Topics</u>. "What Would You Do" case studies are found at the end of each chapter. Your professor has chosen one chapter from the chapters studied during each week that will be discussed in the forum. Students must read the chapters and analyze the cases prior to participating in these forums to contribute value added discussions to the forums. Student evaluations for these forums will be based on the accuracy and depth of the discussions

<u>Initial Posts</u>. Your initial posts and subsequent replies should be thoughtful, considerate, and use college-level language and grammar. Be thorough; your initial posts should be a minimum of 250 words. Remember, you are being graded for your posts just as if they were a test or paper; therefore, you should thoroughly discuss the issues presented in the forum.

Replying to the Postings of Your Classmates. In addition to writing your own initial response to the forum, each week you will compose a response to at least one post made by other students. You should include the following issues in your replies to other students as appropriate:

- 1) Expand on or clarify points made in the initial post.
- 2) Offer an additional argument, either for or against the position taken in an answer.
- 3) Suggest ways in which an idea could be more clearly expressed.
- 4) Identify passages where you think the writer misunderstood a concept or applied it incorrectly.
- 5) Disagree with a point or position made in an answer.

If you are disagreeing with the views of another student, please be constructive and respectful. You may criticize a position but not the author. Just writing "Your position on outsourcing stinks" will not do! State precisely the point you disagree with. (Make sure you have not misinterpreted the writer's position.) Offer reasons why you think their view is incorrect and support your position by citing the text or other sources.

<u>Initial posts must be completed by Thursday at 11:55 p.m. and replies to other student posts must be completed by Sunday at 11:55 p.m.</u>

<u>Late Work:</u> will not be accepted unless extenuating circumstances exist. If possible, students must notify the professor prior to the absence. If not, they shall notify the professor as soon as reasonable. The professor reserves the right to decide whether or not an excused absence will be granted.
