Knowledge Demonstrations

Student comprehension of the material covered in this class will be measured by two tests (Mid-Term and Final Exam) and a research paper. The format of exams may consist of multiple choice, essay, short answer, true false, and case study. Professor reserves the right to have pop-quizzes to measure student comprehension throughout the semester.

There will be NO makeup exams or knowledge demonstration unless emergency, which is not inclusive of oversleeping, forgetting, not enough preparation time, other tests, tired, break-up with significant other, car trouble, missed flight or train, etc.

Those arriving after the class has started will not be allowed to take the knowledge demonstration.

Criminal Law Research Paper

Students will be required to complete a **5 page** research paper in **APA format** with a minimum of **6 references** with only 3 being internet web sites. It should be an original work that demonstrates the student's learning. A handout will be provided later in the semester outlining the research paper assignment and expectations.
