Course Description

3 Credits

Prerequisite: None

This course will prepare the student to evaluate and make recommendations concerning long-term care theory and practice. The course will promote the student's understanding of new approaches to long-term care, incorporating technology and considering cultural diversity and voluntary versus paid services. Issues of cost, insurance and governmental involvement will also be examined.

- Summarize the changing components of long-term care
- Illustrate the English philosophy of care that shaped early colonial policy along with the development of long-term care services over the years
- Analyze existing law and the involvement of the U.S. government in the long-term care division
 of the healthcare industry through policy making and Medicare/Medicaid funding
- Identify age-friendly communities along with being able to justify where, how, and why older adults age in place
- Describe interventions that promote and enhance family involvement in long-term care options
- Analyze and critique the topic of ethics and aging especially in the areas of hospice and palliative care
