



#### **Course Information**

**Course Description:** Focuses on a variety of issues concerning the nature of cultural identity within our pluralistic society. #### **Assignments**

Exams: There will be three exams, each worth 80 points. Exams will be based on material from the assigned readings, lectures, discussions, videos, and any other material presented in the course. The final exam will not be comprehensive but will cover only the material since the previous exam. The test format may be a combination of multiple choice questions and T/F questions.

Quizzes: There will be a quiz for each of the thirteen non-exam modules. Each quiz is worth 5 points. The quiz format will be a combination of multiple choice and T/F questions.

Papers: There will be 1 paper worth 60 points. Details concerning the nature of the paper (topic, length, due date, etc.) will be provided later in the course. No research is required beyond the assigned readings for the course.

Common Learning Outcome Assessment AY20: This assignment functions as a survey of sorts and will help me assess the effectiveness of this course. The assignment will require you to offer a brief reflection on 3 questions concerning a few key themes from the course. No research is required. It is due during the last week of the class and is worth 20 points.

Discussion: Participation in discussions is an important part of the course. Each weekly module will contain specific instructions pertaining to the discussion board. Unless otherwise stated, original posts must be at least 200 words in length and will be due by Friday of each week, and 2 replies to your peers of no less than 75 words each will be due by the last day of each module (a Monday). I expect your posts and replies to be thoughtful and substantive. With one exception, discussion assignments will be worth 10 points. The discussion assignment for module 15 is the one anomaly. It's worth 50 points and requiring a minimum of 500 words.

#### Absence/Illness

Because this course can be completed completely from home and students are provided 10 days in which to complete the assignments for each module, I very rarely give excused absences for absences due to illness. Of course, exceptions can be made for absences resulting from serious, long lasting illnesses that prevent students from completing their work. Students are encouraged to contact the instructor ASAP if they believe that their illness will effect their ability to remain up to date in the class.

### Academic Integrity Violations

Generally, academic dishonesty involves misrepresenting another's work as one's own. This can include cheating (giving or receiving unauthorized assistance, using another

student's work), plagiarism (using or paraphrasing another person's language without proper citation, submitting work found on the internet as one's own), and other forms of misconduct including submitting work from a previous course, attempting to achieve an unfair advantage over other students, and submitting false information to the instructor. Academic dishonesty will not be tolerated in any course at NICC. #### Late Work

Discussion board posts, quizzes, and exams not submitted during the time allotted for each learning module are late and will not be accepted. Although Discussion board posts are due on Friday during each module, they will still be accepted for half credit until the last day of the module. Once a learning module ends, no assignments (with the exception of papers) that were due during that module will be accepted.

Late papers will be accepted with no penalty during the 24 hours following the due date. After the 24 hour grace period ends, the assignment dropbox will close (i.e., you will be unable to submit your paper), and you will receive a zero for the assignment.

The instructor strongly advises students to work on and submit discussion board posts, quizzes, and exams soon after the module is available in order to leave oneself some "wiggle room;" this will allow for "down time" when systems are not working perfectly or when unexpected events come up in your lives.

## Missing Assignments

Missing Assignments will be marked as a zero.
