## **Christian World View & Teaching Philosophy**

In Romans 12:2, the Apostle Paul enjoins his readers, "Do not conform any longer to the pattern of this world, but be transformed by the renewing of your mind.

Then you will be able to test and approve what God's will is—his good, pleasing and perfect will." The kind of growth described here requires an openness to change, and reading helps people engage the world outside the self as they pursue wisdom by weighing their assumptions against the evidence of experience and knowledge acquired through study. Reading begets speech and writing, media through which people respond to new ideas. Thus the university, a community of language makers, is a place where transformations, mental and spiritual, can occur.

### **Course Description**

This course offers an introduction to great literature, the study of which helps students deepen their understanding of the world while becoming better thinkers and writers.

**Required prerequisite**: ENGL 1213 (with a final grade of C or higher)

## **Course Objectives**

Upon successful completion of ENGL 2213, students should be able to do the following:

- 1. interpret literary texts effectively;
- 2. identify generic conventions of epic poetry, lyric poetry, drama, the novel, and non-fictional prose;
- 3. identify key literary terms that are useful for interpreting texts;
- 4. write interpretative essays that are well-organized and clearly expressed and that contain proper citations;
- 5. discuss universal themes that connect literary works as well as the ways that cultural differences shape literary expression;
- 6. discuss ways that texts can operate as tools for examining faith issues.

## **Course Requirements**

1. Creating essays is one way to practice interpretation, which is the essential activity of academic life, and convincing interpretations feature plenty of supporting evidence and commentary. With the goal of becoming a better interpreter of texts,

each student will create several essays based on their readings and research, citing any outside resources in MLA style.

- 2. Exam: Students will take exams over foundational information for interpreting literature, specifically over genre and genre characteristics.
- 3. Participation: Participation includes meeting deadlines for assignments.

### Cheating

Cheating on an examination, assignment, roll sheet or other course related work or activities undermines the ethics of the academy and the specific Christian purposes of Oklahoma Christian University. Accordingly, students who cheat on examinations, assignments or other course related work or activities will face serious consequences, as outlined in this policy.

### Plagiarism

One particular form of cheating is plagiarism. Plagiarism is the transmission of another's ideas, words, or materials as one's own and/or the failure to credit accurately the ideas, words, or materials of another. Plagiarism also includes passing off another's work (a friend, a parent, a website) as one's own. Plagiarism undermines the ethics of the academy and the specific Christian purposes of Oklahoma Christian University. Accordingly, students who engage in plagiarism in assignments submitted will face serious consequences, as outlined in this policy.

### **Penalties for Academic Dishonesty**

- 1. On the first offense, the student will receive zero (0) credit for the examination or assignment. For forms of cheating or dishonesty other than on examinations or assignments, the Professor shall have the discretion to impose an appropriate penalty. Professors must send documentation of the first offense to the appropriate chair, the dean of the appropriate college, the VPAA, and the Dean of Students.
- 2. On the second offense in the same course, the student will receive an F in the course. Professors must send documentation of the second offense to the appropriate chair, the dean of the appropriate college, the VPAA, and the Dean of Students.
- 3. At either the first offense or second offense, the student may appeal using the process described in both the *OC Student Handbook* and the *OC Academic Policy Manual* covering Grade Appeals.
- 4. If the student commits offenses in two or more courses, the Academic Appeals

Committee, described in the *OC Student Handbook* and in the *OC Academic Policy Manual*, may assign penalties for academic dishonesty in addition to the penalties assigned by the professors in the courses. The Academic Appeals

Committee may impose penalties up to and including suspension from the University in instances where a student has engaged in cheating or plagiarism in two or more courses. The Academic Appeals Committee will inform the VPAA and the Dean of Students in writing of any penalties

- imposed by it and will report annually on its activities to the University's Academic Affairs Committee.
- 5. Professors should maintain the highest standards of academic honesty both in and out of the classroom. Professors must report and apply the rules regarding cheating/plagiarism to the appropriate channels. The student should be referred to the Oklahoma Christian University Covenant for principles which should guide conduct in these matters.
