**SECTION 4: ASSESSMENTS** 

#### **Presentation: Negative Media Campaigning**

#### **Description**

#### **Prompt**

After reviewing the module's assigned readings, take a fresh, new look at the media as it relates to the viewpoint society has on the criminal justice system in America. Find a minimum of three articles that support you position as to whether the media does or does not strongly influence the public's opinion in a negative way on the criminal justice system (law enforcement officers, judicial members, and prosecutorial agency). Summarize your articles in an interesting way (creativity would receive lots of praise) and then state your opinion on the effect of medial or public opinion on an individual's perspective of the criminal justice system. Finally, propose a solution to any problem that may be caused by the media OR defend how there are no solutions needed because there are no problems.

#### **Specific Requirements**

- A minimum of seven minutes for a video submission OR 10 PowerPoint visual slides is required to sufficiently address material.
- A minimum of three sources cited is required.

Feel free to use Screencast-O-Matic to record your presentation. <u>Screencast-O-Matic</u> is a free app/tool that is available for recording your screencast. <u>This video</u> provides a brief introduction/guide to using Screencast-O-Matic's free screen recorder.
