This course examines the accounting concepts and practices used in the recording, classifying and reporting of cost data. An analysis is made of the behavior of costs and its use to management in the planning and control process. Budgeting standard cost, job order and process are examined, along with special problems in cost accounting.



### Discussions/Participation – 15%

Your active participation in the discussion forums is essential to your overall success this term. Discussion questions are designed to help you make meaningful connections between the course content and the larger concepts and goals of the course. These discussions offer you the opportunity to express your own thoughts, ask questions for clarification, and gain insight from your classmates' responses and instructor's guidance. Requirements for Discussion Board Assignments: Students are required to post one (1) initial post and to follow up with at least two (2) response posts for each discussion board assignment. Students should refer to the undergraduate discussion rubric for specific

### For your initial post (1), you must do the following:

- Make sure you are using proper APA citation methods for your discipline when referencing scholarly or popular resources.
- In order to receive full credit, participants must post an initial response by 11:55 p.m. on Thursday and a reply to at least two classmates and faculty by 11:55 p.m. on Sunday. Each posting should be substantive and comprehensive. Responses must be at least three to five sentences in length and add value to the discussion. Integrate biblical perspectives in the context of the discussion.

For your response posts (2), you must do the following:

- Reply to at least two different classmates outside of your own initial post
- Complete the two response posts by Sunday 11:59 p.m. Eastern
- Demonstrate more depth and thought than simply stating that "I agree" or "You are " Guidance is provided for you in each discussion prompt.

Class Participation includes readings, videos, and/or weekly activities.

#### Case Study - 15%

In Sessions Three and Five, the student will submit comprehensive answers to questions at the end of the assigned case as prescribed. These answers should indicate critical analysis of the issues, apply research and accounting standards where applicable. The answers to these short cases are to be submitted in the appropriate format depending on its qualitative or quantitative nature. For example, a qualitative answer may be in a Word document of no less than 200 words; while a quantitative answer might be an Excel worksheet. APA guidelines should be followed in either case with a cover page and reference page, typed, 12-font, double spaced. Refer to the assignment rubric and the sample Case Study with APA formatting provided in Canvas.

The purpose of these cases is to broaden the student's business and accounting perspective and understanding. In

re-reading and editing your work to make it more clear and concise will be very important in grading this paper.

## Homework – 25%

Each week numerous exercises are assigned for homework. Homework will involve reading the text or other assigned materials and preparing the answers to the assigned problems to the best of your understanding of the material and your ability. Homework assignments will be completed in McGraw-Hill Connect Lab website. Students will have unlimited attempts to complete the homework assignments. Access to this website is to be purchased along with your textbook.

Completing the homework assignments is a minimum requirement for learning the material and succeeding in this class. Homework assignments will be graded immediately upon submission of work in the accounting lab, but will be transferred into the Canvas gradebook by the instructor. The "best" grade on an assignment will be the final grade in the Canvas gradebook.

## Quiz - 25%

Each week the student will complete a quiz assessment to measure the student's knowledge of the subject matter for that week. The majority of the test questions will be in a multiple-choice format, ranging from 10 to 30 questions. The tests are open book, limited to three hours, and may be taken only once. Quizzes are available as of the first week of class. If a student has read the assigned chapters, completed all the exercises and problems assigned, he/she should be successful on the quizzes. All quizzes will be available and must be submitted in Canvas. Quiz results will be available immediately. Each student should make sure they have enough time to complete the quiz before opening the quiz. It is important to find a quiet place to work on the tests with minimal distractions.

## Final Assessment – 20 %

There will be one comprehensive exam in this course taken in week 7. The majority of the test questions will be in a multiple-choice format. The tests are open book, limited to three hours, and may be taken only once. Tests are available for a limited period of time and are not available prior to the week of the test. If a student has read the assigned chapters, completed the assessments, and all the exercises and problems assigned he/she should be successful on the tests. All tests will be available and must be

submitted through the McGraw-Hill Connect Lab. The Exam will be graded by the lab and results will be available immediately. Each student should make sure they have enough time to complete the test before opening the test. It is important to find a quiet place to work on the tests with minimal distractions.

# **Attendance Policy**

Hybrid courses are a combination of online and classroom activities. Students are expected to attend all campus class meetings as well as to adhere to posted online deadlines for assignments. Online attendance is based on completion of at least one designated assignment by the due date/time posted within the course site for each session. Online activities may include lecture, assignments, readings, discussion forums, and assessments (e.g. quizzes, tests).

# Late Assignment Policy

## **Assignments**

Meeting assigned due dates is critical for demonstrating progress and ensuring appropriate time for instructor feedback on assignments. Students are expected to submit their assignments on or before the due date. Assignments are due by midnight on the days specified. Students can expect a 20% reduction of their grade for each day an assignment is late.

Students who submit assignments more than four days late will receive a grade of zero on the assignment.

In the case of extenuating circumstances (such as hospitalization, child birth, major accident, injury or bereavement), it is the responsibility of students to contact the instructor as soon as practicable. The instructor may waive the late penalty if the circumstances are justified.

Students must submit final course assignments no later than the last day of the term. No assignments are accepted after the last day of the term.

## **Discussions**

Students must submit discussion board postings during the time frame indicated. Discussion board submissions will not be accepted for credit after the deadline.

## Communication

The course site (Canvas) and SWU email are the primary tools for class communication, assignments, handouts, etc. All participants must have access to the course site and SWU e-mail and are expected to access them on a daily basis.
